

# **Request to The State of Oregon Law Enforcement for a Grand Jury Criminal Investigation into the Crimes of Covid-19**

## **From the National American Renaissance Movement**

### **PRELIMINARY STATEMENT:**

There is an age-old idiom, “Can’t see the forest for the trees”. In this case of the Covid-19 pandemic in which we are all immersed, it is difficult for many to see the Covid-19 problem from a more detached perspective. When the historical context of the crimes is understood, with some separation in time, the crimes themselves become easier to understand, as better visibility is gained.

1. **Racketeering, The Racketeer Influenced and Corrupt Organizations Act (RICO)**  
**Federal Statute 18 U.S.C 1961 is not a single crime, but an organized scheme involving other crimes and Oregon Revised Statutes 166.720**

The RICO Act provides for prosecution of racketeering activities as part of an ongoing criminal investigation which is designed to address the infiltration of legitimate enterprises by organized

crime and other illegal ventures. RICO leaders can be held liable for crimes they order others to perform in furtherance of the ongoing criminal organization.

“It is unlawful for anyone employed by or associated with any enterprise engaged in, or the activities of which affect, interstate or foreign commerce, to conduct or participate, directly or indirectly, in the conduct of such enterprise’s affairs through a pattern of racketeering activity or collection of unlawful debt.”

This Covid Enterprise is engaged in activities which affect both interstate and foreign commerce.

According to the Justice Department to successfully convict someone on federal racketeering charges, federal prosecutors must prove that:

1. A criminal enterprise existed
2. The enterprise affected interstate commerce
3. The defendant was associated with or employed by the enterprise
4. The defendant engaged in a pattern of racketeering activity
5. The defendant participated in at least two acts of racketeering over a ten-year period.

The **Enterprise** in this Covid-19 case consists for the most part of organized white collar criminals implementing a global looting scheme at an unprecedented level which includes individual federal employees and their departments of employment, pharmaceutical CEO’s and their corporations, major media, major social platforms, hospital administration, university professors and their schools, NGOs, non-profits and international banks which is orchestrated from behind the curtain or Deep State for a number of nefarious purposes including the making of billions of dollars in illegal profit from harmful injections, the collapse of the economies of Nation States to sabotage National Sovereignty throughout the world especially the United States through accumulation of catastrophic debt, to further deplete the resources of the middle class and poor, to undermine the United States Constitution and its Bill of Rights and the Freedom and Sovereignty of United States citizens, and to debilitate, weaken and reduce the world’s population through the injection, without informed consent, into billions of individuals of experimental “vaccines, which are bioweapons of undisclosed content but which harbor toxic, nano lipid particles, spike protein, mRNA technology, self-assembling systems and other toxic substances for an experimental die-off, herding the human race towards transhumanism and the control by artificial intelligence known as the coming “4th Industrial Revolution”, digital slave economy.

These crimes amount to a quiet class-war on the world with silent weapons, in particular in the United States where the pandemic death count has been highest. This pattern of racketeering activity is an integral part of a global cabal intent on world domination which has in name metamorphosized from the New World Order to “The Great Reset”.

The “pattern of activity” requires at least two acts of racketeering activity,” one of which occurred after the effective date of the RICO statute and the last of which occurred within ten years after the commission of a prior racketeering act. There also must be proof that the racketeering acts are related to, and amount to, or pose a threat of, continued criminal activity

RICO allows law enforcement officials to file cases against an entire racket. **The law allows prosecutors to seize the assets of an indicted party, thereby preventing the transfer of funds and property through shell companies.** Providing more tools to law enforcement agencies to combat racketeering, the law allows prosecutors to charge organizations or individuals for up to 20 years of ongoing criminal activity for each count of racketeering. The law also allows prosecutors to charge organization leaders for crimes that they ordered others to commit.

Federal and state prosecutors must prove beyond a reasonable doubt the extent of any crimes committed and the involvement of those involved in order to apply them to the RICO Act when charges are filed.

Criminal penalties of racketeering include imprisonment not to exceed twenty years. However, If the RICO activity is based on racketeering activity that is charged as a predicate act and for which the maximum penalty includes life imprisonment, then the maximum penalty for the RICO violation is life imprisonment.

The Predicate crimes for this racketeering charge include: fraud, domestic terrorism, murder and aggravated assault.

### **Oregon Rev Stat § 166.720 (2015)**

(1) It is unlawful for any person who has knowingly received any proceeds derived, directly or indirectly, from a pattern of racketeering activity or through the collection of an unlawful debt to use or invest, whether directly or indirectly, any part of such proceeds, or the proceeds derived from the investment or use thereof, in the acquisition of any title to, or any right, interest or equity in, real property or in the establishment or operation of any enterprise.

(2) It is unlawful for any person, through a pattern of racketeering activity or through the collection of an unlawful debt, to acquire or maintain, directly or indirectly, any interest in or control of any real property or enterprise.

(3) It is unlawful for any person employed by, or associated with, any enterprise to conduct or participate, directly or indirectly, in such enterprise through a pattern of racketeering activity or the collection of an unlawful debt.

(4) It is unlawful for any person to conspire or endeavor to violate any of the provisions of subsections (1), (2) or (3) of this section.

(5)(a) Any person convicted of engaging in activity in violation of the provisions of subsections (1) to (4) of this section is guilty of a Class A felony.

(b) In lieu of a fine otherwise authorized by law, any person convicted of engaging in conduct in violation of the provisions of subsections (1) to (4) of this section, through which the person derived a pecuniary value, or by which the person caused personal injury or property damage or other loss, may be sentenced to pay a fine that does not exceed three times the gross value gained or three times the gross loss caused, whichever is greater, plus court costs and the costs of investigation and prosecution, reasonably incurred.

(c) The court shall hold a hearing to determine the amount of the fine authorized by paragraph (b) of this subsection.

d) For the purposes of paragraph (b) of this subsection, "pecuniary value" means:

(A) Anything of value in the form of money, a negotiable instrument, a commercial interest or anything else the primary significance of which is economic advantage; or

(B) Any other property or service that has a value in excess of \$100.

(6) An allegation of a pattern of racketeering activity is sufficient if it contains substantially the following:

(a) A statement of the acts constituting each incident of racketeering activity in ordinary and concise language, and in a manner that enables a person of common understanding to know what is intended;

(b) A statement of the relation to each incident of racketeering activity that the conduct was committed on or about a designated date, or during a designated period of time;

(c) A statement, in the language of ORS 166.715 (4) or other ordinary and concise language, designating which distinguishing characteristic or characteristics interrelate the incidents of racketeering activity; and

(d) A statement that the incidents alleged were not isolated.

[1981 c.769 §§3,4; 1997 c.789 §2]

1. **FRAUD: 18 U.S. Code §1031.** Major fraud against the United States, and (a) Whoever knowingly executes, or attempts to execute, any scheme or artifice with the intent-

1) to defraud the United States; or

(2) to obtain money or property by means of false or fraudulent pretenses, representations, or promises, in any grant, contract, subcontract, subsidy, loan, guarantee, insurance, or other form

of Federal assistance, including through the Troubled Asset Relief Program, an economic stimulus, recovery or rescue plan provided by the Government, or the Government's purchase of any troubled asset as defined in the Emergency Economic Stabilization Act of 2008, or in any procurement of property or services as a prime contractor with the United States or as a subcontractor or supplier on a contract in which there is a prime contract with the United States, if the value of such grant, contract, subcontract, subsidy, loan, guarantee, insurance, or other form of Federal assistance, or any constituent part thereof, is \$1,000,000 or more shall, subject to the applicability of subsection (c) of this section, be fined not more than \$1,000,000, or imprisoned not more than 10 years, or both.

(b) The fine imposed for an offense under this section may exceed the maximum otherwise provided by law, if such fine does not exceed \$5,000,000 and-

(1) the gross loss to the Government or the gross gain to a defendant is \$500,000 or greater; or

(2) the offense involves a conscious or reckless risk of serious personal injury.

(c) The maximum fine imposed upon a defendant for a prosecution including a prosecution with multiple counts under this section shall not exceed \$10,000,000.

**(d) Nothing in this section shall preclude a court from imposing any other sentences available under this title, including, without limitation, a fine up to twice the amount of the gross loss or gross gain involved in the offense**

#### **Oregon Revised Statutes 165.037 Criminal simulation**

(1) A person commits the crime of criminal simulation if:

(a) With intent to defraud, the person makes or alters any object in such a manner that it appears to have an antiquity, rarity, source or authorship that it does not in fact possess; or

(b) With knowledge of its true character and with intent to defraud, the person utters or possesses an object so simulated.

(2) Criminal simulation is a Class A misdemeanor. [1971 c.743 §157].

## **FEDERAL STATUTES AND THE BIOLOGICAL WEAPONS ANTI-TERRORISM ACT OF 1989 AND A PRESIDENTIAL ORDER TO DESIST**

### **CREATION OF FIRST BIOWEAPON:**

Gain of Function research is the taking of a living organism and making it more lethal, and turning it into a biological weapon. This type of experimentation was made illegal in the United States by the Biological Weapons Anti-Terrorism Act of 1989 drafted by Francis Boyle, Esq. and approved unanimously by both Houses of Congress and signed into law by President George W. Bush.

The patents on this controversial research involving Covid viruses went back many years according to patent expert Dr. David Martin of -M- CAM-in an interview with Reiner Fuellmich, Esq. **(1. Exhibit 10)**, <https://www.youtube.com/watch?v=WuVlaf-WedM>

David Martins Totality of Evidence is a collection of his videos addressing the Covid 19 crimes **(2. Exhibit 11, David Martin)**, , <https://totalityofevidence.com/dr-david-martin/>

A history of the patent work showed a gradual engineering of a new pathogen in a laboratory. Gain of function was illegal although being done and in 2014 President Obama called for a halt to it.

### **Prepping the Ground for a COVID-19 Pandemic, a short time-line.**

1.The search for DNA vaccines goes back at least to 2003 in the midst of the SARS-CoV-1 epidemic. In 2006 Dr.Ralph Baric was working with spike proteins similar to the ones in current vaccines which failed to protect and resulted in enhanced immunopathology with eosinophilic infiltrates within the lungs of CoV-challenged mice. The research involved creating “chimeric” viruses indicating gain of function research. **(3. Exhibit 1 Covid-19 and The Global Predators: We are the Prey, Peter and Ginger Breggin, 173)**

2. A fatal flaw existed in the experiments which researchers were never able to overcome- that, animals vaccinated for SARS-Covid infections with mRNA or DNA vaccines experienced serious illness and death when challenged by SARS-CoV pathogens. The illness often resembled what is now called COVID-19. **(4. Ibid)**

3. In 2011 Dr. Ralph Baric in a research article funded by Fauci’s NIAID and the University of North Carolina found that aged animals displayed increased eosinophilic immune pathology in the lungs and were not protected against significant virus replication. When challenged with zoonotic and human chimeric SARS-CoV incorporating variant spike glycoproteins the aged mouse model reproduced severe lung damage associated with human disease, including alveolar damage, hyaline membrane formation and death **(5. Ibid, 174)**

4. In 2013 Dr. Ralph Baric and his team of researchers received a 10-million-dollar grant from the NIH to study the pathogenic activity of viruses including sever acute respiratory syndrome

(SARS), Middle East respiratory syndrome (MERS), Ebola, highly pathogenic influenza and herpes virus HHV8

5. In 2014 President Barack Obama instructed work on the gain of function to stop.

6. In 2015 Drs. Ralph Baric and Vincent Menachery working with the blessings of Dr. Anthony Fauci and the National Institute for Allergies and Infectious Disease (NIAID), and Francis Collins and the National Institute of Health (NIH) continued experimentation at the University of North Carolina, Chapel Hill with China's Wuhan Institute of Virology on Covid 19 SARS 2 pathogen. Chinese bioweapons expert Shi Zhengli known as the "bat woman" was also working with them. The paper Dr. Baric wrote with other scientists was entitled, **"A SARS-like cluster of circulating bat coronaviruses shows potential for human emergence."**

The scientific work thereafter, moved from University of North Carolina to Wuhan, China.

7. On January 10, 2017, a few days before the Presidential Inauguration Anthony Fauci announced, **"a pandemic was inevitable in the coming administration of President Trump"** (8. Exhibit 1). **Breggin Ibid, 247).** He further clarified, **"If there is one message that I want to leave with you today based on my experience is that there is no question that there will be a challenge to the coming administration in the area of infectious diseases...but also there will be a surprise outbreak"** (9.Ibid, 248). Fauci continued, **"We will definitely get surprised in the next few years so the thing we are extraordinarily confident about is we are going to see this in the next few years."**

8. On January 13, 2017 the Coalition for Epidemic Preparedness Innovations (CEPI) was announced at Davos, Switzerland by Bill Gates and Klaus Schwab of the World Economic Forum (WEF) **(10. Ibid, 230)** which stresses innovative partnerships between public, private, philanthropic and civil organizations to develop vaccines against diseases with epidemic potential.

9. On January 15, 2017 the Food and Drug Administration (FDA) announced new guidelines for improving Emergency Use Authorization (EUA) to allow very rapid vaccines development when confronted with a pandemic emergency.

10. On January 18, 2017 Bill Gates outlined a Warp Speed strategy and that Moderna was developing a new delivery system for RNA vaccines

11. On January 24, 2017 Bill Gates said at a press conference that, **"a worldwide pandemic was the most likely massive, upcoming threat to humanity."** **(11. Ibid, 237)**

In early 2017 Bill Gates was already investing in and internationally organizing individual, corporate and government wealth and power in preparation for a Warp Speed approach to a coming pandemic which would stream-line the vaccine approval process to less than a year. **(12. Ibid, 240)**

12. In March 2017 Bill Gates announced that CEPI collected \$460 million for epidemic preparedness. **(13. Ibid, 247)**

13. April 30, 2017 Gates, with incredible foresight pushed Remdesivir and Fauci gave Dr. Ralph Baric \$6 million to accelerate Remdesivir at Wuhan as a corona virus remedy **(14. Exhibit 2, The Real Anthony Fauci, Robert F. Kennedy, Jr. p. 64)**

14. By the end of 2017 Bloomberg School of Public Health at John Hopkins joined Gates tooling up for a pandemic by publishing a 76-page future scenario specifically preparing for a corona virus pandemic and production of vaccination **(15. Exhibit 1, p. 237)**

15. In 2018 Peter Daszack of Eco Health Alliance which was working with both the American and Chinese scientists on the Covid pathogen approached DARPA about getting involved with genetic manipulation creating of a furin cleavage site which was a gain of function to make the Covid pathogen more lethal. DARPA declined. (16. Exhibit 55. **Furin Cleavage Site is key to Sars- Co-V 2 Pathogenesis**, Pub Med <https://pubmed.ncbi.nlm.nih.gov/32869021/>)

16. From January through August 2019 **Crimson Contagion**, a joint exercise conducted by the Department of Health and Human Services unfolded, led by Robert Kadlec and involving numerous national, state, local government and public and private organizations testing response to a simulated severe pandemic of influenza originating in China

17. In October 18, 2019, John Hopkins Center for Public Safety (Bloomberg) in collaboration with Bill and Melinda Gates Foundation and the World Economic Forum (Schwab) conducted **Event 201**, a 3.5-hour table-top pandemic war game simulation featuring an immune resistant novel respiratory corona virus with devastating impact and rapid spread countered by blitzkrieg roll-out of vaccines but with a total exclusion of treatments with already licensed repurposed medicines. The Event included the director general of Chinese CDC

18. On or about November 2019 concern grew in China over the outbreak of a new disease. News reports around the world said the novel Covid-19 virus came from human exposure to a bat supposedly in a wet market in Wuhan, China. In a short time, the disease was elevated to a world-wide pandemic status, although then and to this day the “virus” has not been isolated and purified for proper identification purposes.

19. On March 11, 2020 WHO declared COVID-19 pandemic. Lockdowns become a reality.

20. On March 16, 2020 NIAID announced beginning a clinical trial of new investigational vaccine at the Kaiser Permanente Washington Research Institute (KPWHRI) Seattle, Moderna Inc. mRNA -1273 supported by CEPI (**20. Exhibit 4, The Courage to Face Covid-19, Peter McCullough and John Leake, p.30**) implementing CEPI plan, five days after the pandemic declaration.

21. Both NIAID and NIH had been funding gain-of-function research with corona viruses before 2014 some of the research being done in Wuhan and at other times at the University of North Carolina in developing a deadly SARS-CoV virus (**21. Exhibit 1, Breggin 34**)

22. In April 2020 Li-Meng Yan, an experienced Chinese virologist at the Hong Kong School of Public Health escaped to the United States. She claimed that the virus is not actually from nature but a man-made virus created in a lab. She claimed Wuhan Institute possess the world’s largest collection of corona viruses and that there is a link to the Chinese military. (**22. Ibid, 74**)

23. On January 24, 2020 Professor Francis Boyle, Esq. who had drafted the Biological Weapons Anti-Terrorist Act which had been approved unanimously by both Houses of Congress in 1989 stated in an interview with *Geopolitics & Empire* that the Wuhan corona virus was an offensive biological warfare weapon involving DNA genetic engineering that included gain-of-function properties to make it more lethal and infectious. (**23, Exhibit 3, Resisting Medical Tyranny, Francis A. Boyle, Esq., p.6**)

24. In a treatise dated January 29, 2021 Carl Quay MD, PhD concluded that SARS-CoV2 is not a natural zoonosis but instead is laboratory derived with the probability of laboratory origin for CoV-2 at 99.8% while the probability of emergence from nature at 0.2 %. (**24. Exhibit 1, p. 42**) The collaborating team made genetically engineered mice with human ACE-2 receptors and created a successful SARS-CoV-2 infection model using the transgenic mice. (**25. Ibid 51**)

25. On May 11, 2021 Anthony Fauci denied that the NIH now or ever financed gain of function research in Wuhan Institute of Virology or at the University of North Carolina with Ralph Baric **(26. Ibid, 26)**

26. August 27, 2020 NIH awarded a \$7.5 million grant to Eco Health Alliance

27. In October 2020 Dr. Yan and three colleagues put a second paper on the internet, titled, **“SARS -CoV-2 Is an Unrestricted Bioweapon: A Truth Revealed through Uncovering a Large Scale, Organized Scientific Fraud.”** 27. **(Exhibit 89)**

The experimental work on the Covid-19 pathogen, spike protein and mRNA nano lipid delivery system had been sent to Wuhan, China for completion. The Wuhan Institute of Virology is a Chinese BSL 4 military bioweapon facility akin to the United States’ Fort Detrick. Covid-19 was being created as a bioweapon in a laboratory.

According to Dr. Joseph Mercola, “Weaponized **Virus**”, SARS-CoV-2 , is a joint Chinese/U.S. creation, a likely genetically engineered, mutant offspring of decades-long biological arms race, disguised as gain-of-function biomedical, vaccine or biosafety research.” **(28. Exhibit 5, The Truth About Covid-19, Dr. Joseph Mercola, p.67)**

Anthony Fauci appears to have lied while testifying to Congress on May 11, 2021 that he and the National Institute of Health (NIH) were never involved in financing gain of function research project which had been sent to China from the University of North Carolina and continued to be financed by creating a subterfuge by transferring \$7.5 million for the Wuhan Institute project through Peter Daszak and his company ECO Health Alliance which was involved with the COVID project and working in China.

Some kind of threshold has been crossed,” said Alina Chan, a Boston-based scientist and co-author of the upcoming book “Viral: The Search for the Origin of Covid-19.” Chan has been vocal about the need to thoroughly investigate the possibility that SARS-CoV-2 emerged from a lab while remaining open to both possible theories of its development. For Chan, the revelation from the proposal was the description of the insertion of a novel furin cleavage site into bat coronaviruses — something people previously speculated, but had no evidence, may have happened. (29. Exhibit 90

“Let’s look at the big picture: A novel SARS coronavirus emerges in Wuhan with a novel cleavage site in it. We now have evidence that, in early 2018, they had pitched inserting novel cleavage sites into novel SARS-related viruses in their lab,” said Chan. “This definitely tips the scales for me. And I think it should do that for many other scientists too.”

Richard Ebright, a molecular biologist at Rutgers University who has espoused the possibility that SARS-CoV-2 may have originated in a lab, agreed. “The relevance of this is that SARS Cov-2, the pandemic virus, is the only virus in its entire genus of SARS-related coronaviruses that contains a fully functional cleavage site at the S1, S2 junction,” said Ebright, referring to the place where two subunits of the spike protein meet. “And here is a proposal from the beginning of 2018, proposing explicitly to engineer that sequence at that position in chimeric lab-generated coronaviruses.”

The furin cleavage site enables the virus to more efficiently bind to and release its genetic material into a human cell and is one of the reasons that the virus is so easily transmissible and harmful

In May of 2021 Dr. Roger Ebright, a professor of chemistry and chemical biology at Rutgers University and biosafety expert contested Anthony Fauci’s testimony before the Senate that the National Institute of Health has ever and does not now fund gain of function research in the Wuhan Institute of Virology as, “demonstrably false”. He stated that the NIH “unequivocally” does, and that the United States taxpayers are funding the research.

With the outbreak of the contagious virus the Public became anxious but treatment for U.S. citizens was placed on hold for 9 months, no treatment protocol recommendations were forthcoming from NIAID, NIH, FDC, CDS, nothing except wait for the vaccines or go to the hospital if you could not breathe. Anthony Fauci then steered the vaccines through the narrow window of Emergency Use Authorization (EUA) which would have been shut to experimental, untested vaccines if a safe and effective treatment for Covid had existed.

The CDC reports, “The overall burden of influenza (flu) deaths for the 2021-2022 season was 5,000 flu deaths (Table 1). What accounts for the vast reduction in flu deaths in 2021-2022?

The Crimson Contagion exercise that Robert Kadlec was directing just before the outbreak of Covid 19 was that of a simulated pandemic caused by a virulent influenza.

Michael Yeadon, a former Pfizer Vice President and lead scientific researcher strongly maintains that Covid-19 does not exist as a novel virus causing the present pandemic but is a media hyped influenza. Dr. Yeadon states that Covid-19 is accompanied by a host of orchestrated lies including: the necessity of lockdowns, effectiveness of lockdowns, effectiveness and need for masking and social distancing, the need for border and business closings, and mass testing. He states that the PCR tests were not reliable, causing extreme inflated numbers of asymptomatic carriers and that all the necessary counter measures accompanying Covid-19 were unnecessary and everything associated with it including the need for vaccines are based on lies...a host of lies. He points out that some public figures were in on the lie as they were sometimes caught partying without protection or concern. He maintained that the vaccines themselves are dangerous and the Public should not take them.

Dr. Yeadon relates how individuals have contacted government Public Health Departments asking them if they have in their possession samples of the Covid-19 virus. They were not asking for samples to study only if they had samples. These individuals received no affirmation that the Public Health Departments were in possession of the alleged Covid-19 samples. The Covid-19 pandemic appears to be then a psychological operation being fortified through media assists and assets and government agency representations, and is really all an illusion and a deception to force feed the Public to take the vaccine. All lies are to be used to get the toxic experimental gene therapy, “vaccine” into the veins of the Public, even into the bodies of little babies.

In order to justify lockdowns and identify sick people a PCR test was used. Kary Mullis the inventor of the PCR had previously stated that it was not be used to make a diagnosis of a live virus because with the right amplification it could find almost anything in one’s medical history. (34, Exhibit 17) <https://rumble.com/vhu4rz-kary-mullis-inventor-of-the-pcr-test.html>

Nevertheless, regulators misused PCR tests. The CDC belatedly admitted in August 2021 that the PCR tests were incapable of distinguishing COVID from other viral illnesses. Dr. Fauci allowed their use at inappropriately high amplitudes of 37 to 45 even though he knew that tests employing cycle thresholds of 35 and above were very unlikely to indicate the presence of live virus that could replicate. (35. Exhibit 2, p. 5)

Polymerase chain reaction test (PCR) was used in 4 US State prisons with nearly 3,300 inmates who tested positive for corona virus 96% without symptoms (36. Exhibit 7, p. 4)

April 2020 the European Journal of Clinical Microbiology and Infectious Disease showed that to get to 100% confirmed real positives, test must be run at 17 cycles. Above 17 cycles, accuracy drops dramatically. By the time you get to 33 cycles accuracy rate is only 20% meaning 80 % false positives. Beyond 34 cycles, your chance of positive PCR test being a true positive shrink to zero. Journal of Infectious Disease stated no live viruses are found in cases where positive PCR test used a cycle threshold above 24 (37. Exhibit 5, Mercola p.79)

An article by Brightwork Research & Analysis, **“How Bill Gates Funded Science Fraud in the PCR Test Development”** documents the Covid 19 fraudulent use of PCR tests to diagnose Covid 19 and lock down the society. (38. Exhibit 81 <https://www.brightworkresearch.com/how-bill-gates-funded-science-fraud-in-the-pcr-test-development/>)

If you want to frighten people, sell more PCR tests, reinstitute lockdowns, all one has to do is require more testing and calibrate the tests so those who are not sick and have no symptoms (contagious) appear to be infected and able to spread Covid19. (39. Exhibit 5, Mercola, p.79)

In Dec. 2020 Florida became first US state to require labs to report the cycle threshold used for their PCR tests. In Portugal the PCR test was ruled unreliable and so was its quarantine based on it. (40, Ibid)

To determine whether the amplified products are indeed SARS-CoV-2 genes, biomolecular validation of amplified PCR products is essential for diagnostic test, this validation is an absolute must. (41. Ibid, p.79) This was not being done.

According to Attorney Reiner Fuellmich, founding member of the German Corona Extra-Parliamentary Inquiry Committee Dr. Christian Drosten is a key culprit in the COVID-19 pandemic hoax (42. Ibid p.80)

The Bill & Melinda Gates Foundation gave \$249,550.00 to Drosten's Charite' Berlin Institute of Virology to develop a rapid response test to the novel 2019 corona virus. The WHO in turn accepted and promoted Drosten's PCR kit (Brightwork Research Analysis, 11/2/21) worldwide

The polymerase chain reaction test (PCR ) of Professor Christian Drosten, and used world-wide was very unreliable as quality control requirements were shelved and his PCR even tested goats and papayas as positive for COVID virus in Tanzania. (48. Exhibit 9, Corona False Alarm, Dr. Karins Reiss and Dr. Sucharit Bhakdi, p.18)

On July 19, 2021 Bill Gates and George Soros backed a consortium to buy a United Kingdom maker of Covid tests for \$41 Million. (Forbes)

The PCR test was used to inflate the number of COVID cases and to create fear and panic. 94% of covid death certificates list routinely co—morbidity. The CDC wants the listing of Covid as primary cause even when Covid is only suspected.

If the alleged Covid 19 is not an identifiable pathogen with gain of function developed jointly by United States and Chinese scientists at the University of North Carolina and Wuhan and or is not influenza hyped up in public panic mode, what then is it?

**FRAUD COUNT II**

**ANOTHNY FAUCI, BILL GATES AND THE ENTERPRISE COMITTED MEDICAL FRAUD WHEN THEY KNOWINGLY AND INTENTIONALLY MISREPRESENTED AND LIED ABOUT LIFE-SAVING MEDICINES SUCH AS HYDROXYCHLOROQUINE AND IVERMECTIN WHICH WERE SAFE AND EFFECTIVE IN TREATING SARS COVID-2 AND THEREFORE OPENED THE EMERGENCY USE AUTHORIZATION (EUA) DOOR FOR THEIR UNTESTED EXPERIMENTAL 'VACCINES'AND DRUGS WHICH WERE INEFFECTIVE AND DANGEROUS**

Under Federal law new vaccines and medicine can qualify for Emergency Use Authorization (EUA) only if there are no FDA approved drugs that already are shown to be effective against the disease.

Dr. Anthony Fauci, Bill Gates and the Enterprise championed experimental vaccines being prepared and ready for EUA approval while safe and effective medicines already existed which made the need for COVID-19 vaccines unnecessary. To accomplish the emergency use for their experimental injections the Enterprise demonized and marginalized the pre-existing safe and effective drugs attacked the medical professionals who supported their use and ruthlessly targeted them in an attempt to destroy their reputations and their professions.

“The suppression of **hydroxychloroquine** and **ivermectin** is one of the greatest tragedies and crimes of the modern era.” According to renowned psychiatrist Dr. Peter Breggin (49. Exhibit 2, RFK Jr. p. 55), author of **“Covid-19 and the Global Predators: We are The Prey.”**

Robert F. Kennedy Jr., Esq. an expert in vaccine litigation wrote in his book, **“The Real Anthony Fauci: Bill Gates, Big Pharma and the Global War on Democracy and Public Health”** (Exhibit 2) “Ivermectin is a thousand times safer than remdesivir and COVID vaccines.” (50. Ibid,60) “Fauci’s suppression of early effective treatment caused 100,000 extra deaths. He didn’t even recommend Vitamin D” (51, Ibid p. 9), RFK Jr. lamented.

Early treatment was a major concern for the public, being assaulted by a mysterious pathogen and Dr. Fauci and his colleagues in the medical profession offered no defense to the public except to go home until they had problems breathing and then to go to the hospital. No early treatment protocol was forthcoming from Fauci, the NIAID, the NIH, the FDA, the CDC. Instead, the Fauci, Gates mantra was to wait at home for the promised vaccines.

Early treatment, however was the key to minimizing the pathogen’s effect and good physicians knew this and front-line doctors being faithful to the Hippocratic oath were offering early effective treatments to their patients using safe and effective repurposed drugs.

Although Fauci and his government agency colleagues never published a treatment protocol, thankfully other doctors did. One of these doctors was Peter McCullough.

Dr. Peter McCullough was at the beginning of 2020, Vice Chief of Internal Medicine and Program Director of Cardiology at the Baylor University Center in Dallas, an internist and cardiologist, professor of Medicine at Texas A&M University, President of Cardiorenal Society of America and

Editor and Chief or Senior Associate editor of 3 major academic journals and on the editorial board of more than a dozen journals., published over 600 peer reviewed academic medical papers and over a thousand medical communications. He is Board certified, awarded 8 additional medical certifications from numerous societies. His credentials are impeccable.

Dr. McCullough's protocol included safe and effective repurposed licensed drugs including: ivermectin, hydroxychloroquine, azithromycin or doxycycline, zinc, NAC, aspirin, Celebrex, bromhexine, famotidine, Pepcid, vitamin D, quercetin and IV C (52. Ibid, 12)). According to Dr. McCullough any combination of these safe medicines would have reduced mortalities by at least 60%.

Data from 18 randomized controlled trials that included over 2,100 patients...demonstrated that Ivermectin produces faster viral clearance, faster time to hospital discharge, faster time to clinical recovery, and a 75% reduction in mortality rates. (53. Exhibit 5, Mercola, p.121))

Like Hydroxychloroquine, Ivermectin, is an antiparasitic drug with well documented safety profile and "proven highly potent, antiviral and anti-inflammatory properties." It's been on the market since 1981 and is listed by WHO as essential medicine, inexpensive, a course costing less than \$2.00 in India and Bangladesh. While US FDA had not approved Ivermectin for prevention of or treatment for SARS-CoV-2 studies have shown Ivermectin. 1) inhibits replication of many viruses, including SARS-CoV-2 and seasonal influenza virus. Dr. Mercola reviewed data of a study showing a single dose of Ivermectin killed 99.8% of SARS-CoV-2 in 48 hours. 2) inhibits inflammation through several pathways, 3) lowers viral load, 4) protects against organ damage, 5) prevents transmission of SARS-CoV-2 when taken before or after exposure; speeds recovery and lowers risk of hospitalization and death in COVID-19 patients. (54. Ibid,122)

Dr. Pierre Kory stated, "Dr. Fauci's suppression of early treatment and off patent remedies will go down in history as having caused the death of half a million people. He and Dr. Luc Montagnier, a French Nobel prize winning doctor both believed that the COVID-19 pandemics could have been stopped using available medicines.

Dr 'Pierre Kory' 'COVID-19' "Propaganda & Censorship Of Proven Generic Drugs & Physicians <https://rumble.com/v2f50u2-dr-pierre-kory-covid-19-propaganda-and-censorship-of-proven-generic-drugs-a.html> (55. Exhibit 139) addresses the ivermectin issue.

Dr. Kory testified before the Senate Committee on Homeland Security and Governmental Affairs on, COVID-19, and stated that Ivermectin is a "miracle drug". He called upon NIH, CDC, FDA to urgently review the latest data and then issue guidelines for physicians, nurse-practitioners and physician assistants to prescribe Ivermectin for COVID 19. (55a. Exhibit 5, 121)

Dr. Kory presented a growing body of evidence, including results of 13 randomized controlled trials showing Ivermectin's efficiency., "Recognize that the amount of evidence that I have presented far exceeds the level required for a compassionate use authorization as defined by

the FDA. That happened for remdesivir, a drug with far less supportive evidence and much higher cost. Why can't it happen for Ivermectin, given this level of evidence...it will all be needless death from here on given there is a readily available solution." (56 Exhibit 4, McCullough, p. 173) NIH, CDC and FDA did not heed Dr. Kory's plea,

**Ivermectin** is a safe and effective medicine. It cures river blindness Onchocerciasis and Lymphatic filariasis commonly known as Elephantiasis. It is FDA approved for parasitic infection and included on the WHO model list of essential medicines, and is thus widely available. (58. Exhibit 4, p. 73) It is a potent killer of parasitic round worms., extremely safe and effective (Merck) "wonder drug". It inhibits replication of yellow fever virus, dengue virus, flaviviruses, Japanese encephalitis and tick-borne encephalitis, potent antiviral action against HIV-1 (59. Ibid, p. 74). 250 million people have taken it annually for decades. Fauci, Gates and the Enterprise knew this.

Studies supporting Ivermectin's efficacy from independent doctors, epidemiological studies in India, Peru, Mexico and clinical trials and Drs. Jean-Jacques and Juliana Cepelowicz Rajter husband and wife team with a pulmonary practice in Fla, were ignored by US Bio-Pharmaceutical Complex until Aug, 27, 2020 when NIH issued a recommendation against its use. In the following 6 months, several additional high-quality studies were completed showing ivermectin efficacy. By Jan. 11, 2021, 64 controlled trials, 32 randomized and 16 double-blinded extremely favorable towards Ivermectin. Still the NIH never recommended the drug and FDA never approved it for COVID-19 not even under, "compassionate use" provisions for sick patients for whom nothing else was working.

Dr. Kylie Wagstaff and a team of researchers from Monash University, Australia published data indicating that Ivermectin was effective in reducing COVID-19 viral loads by 5000-fold within 48 hours in their cell culture models. (61. Exhibit 4, 170)

Uttar Pradesh, one of India's largest states with a population 2/3 of the US, 241 million people eliminated COVID-19 completely with early treatment of Ivermectin. (62. Exhibit 7, Lies My Gov't Told Me, Dr. Robert Malone, p.45)

Successful treatment with Ivermectin was shown in Itajai, Brazil, Mexico, Peru, Argentina, Philippines, Japan and elsewhere. (63. Ibid), (63a, Pub Med Exhibit 130.) Ivermectin Prophylaxis Used for COVID-19: A Citywide, Prospective, Observational Study of 223,128 Subjects Using Propensity Score Matching, <https://pubmed.ncbi.nlm.nih.gov/35070575/>

**Hydroxychloroquine**, an antiparasitic drug like Ivermectin is another wonder medicine. FDA approved and licensed since 1955 and like Ivermectin is very inexpensive, effective and safe. Fauci, Gates and the Enterprise knew this

Hydroxychloroquine plus zinc was successfully used to treat malaria, rashes, inflammatory arthritis. Israeli scientist used it as an anti-inflammatory, anti-thrombotic, antimicrobial (including viral) and immune modulator (64. Exhibit 4, p 37-38)

Dr. Vladimir “Zev” Zelenko. Monroe. NY. 60 miles from New York City successfully treated hundreds of Covid patients with low doses of hydroxychloroquine, azithromycin and, zinc. (65. Ibid, p. 45) while former New York Governor Andrew Cuomo was herding infectious seniors from hospitals into nursing homes which became a “killing fields” for hundreds of the most defenseless. Dr. Zelenko wrote a letter to President Trump and alerted him to the Hydroxychloroquine plus zinc protocol which was allowing him to save people.

Dr. Vladimir Zev Zelenko’s protocol was associated with significantly less hospitalization and five times less all cause deaths. (65, Exhibit 5 p.123). He emphasized early treatment after exposure. Quercetin could be used as a substitute for hydroxychloroquine (66. Ibid, p.214)

The team of Dr. George Fareed and Dr. Bryan Tyson treated with hydroxychloroquine over 7,000 patients with COVID-19 and no one died. The early treatment within 5-7 days of infection and a protocol similar to Drs. Zelenko and McCullough consisting of Hydroxychloroquine and other repurposed medicines is a very successful treatment. (67. Exhibit 8, **Overcoming the Covid Darkness**, Bryon Tyson, M.D. and George Fareed, M.D. p. xv).

Dr. Fareed wrote the following letter to Dr. Fauci concerning hydroxychloroquine, **(68. Exhibit 94.) Open Letter to Dr. Anthony Fauci Regarding the Use of Hydroxychloroquine for Treating COVID-19,**

In South Korea, China, India and France Hydroxychloroquine was recommended by official expert panels multiple clinical studies and observational reports. (69. Exhibit 4, p. 9).

In Spain Hydroxychloroquine is used by 72% of doctors and was rated the most effective therapy by 75% of them taking 400 milligrams/day.

SARS-CoV-2 was closely related to SARS-CoV-1 which had in 2003 also emanated from China (70. Ibid p.11)

In 2014 Julie Dyal researcher for NIAID published a major work titled, **“Repurposing of Clinically Developed Drugs for Treatment of Middle East respiratory Syndrome Coronavirus Infection”** The study stated that hydroxychloroquine and several other compounds demonstrated activity against MERS-CoV and SARS-CoV. These diseases are very similar to SARS-CoV2. Fauci and Gates and the Enterprise knew this but would not condone its use.

At least seven 7 papers published in distinguished journals between 20003-2014 wrote about the anti-viral properties of chloroquine, hydroxychloroquine and zinc.

Professor Didier Raoult used hydroxychloroquine as a prophylaxis in France. He had published 2,300 papers and was the most cited microbiologist in Europe. He and his team discovered 468 species of bacteria, about 1/5 of all those named and described. He has won 13 major awards and is commander of the National Order of Merit but he was opposed by Anthony Fauci’s equivalent in France, Dr. Yves Levy who served as Director of National Institute of Health and Research from 2014-2018 and was part of French delegation that inaugurated the BSL-4 Lab at Wuhan Institute of Virology in 2017. (71. Ibid,24)

Dr. Raoult chose hydroxychloroquine combined with azithromycin because of the anti-viral effect he observed in using it against Zika virus. As for safety profile of these drugs they had been around for decades with billions of doses taken and well tolerated, both drugs being on WHO’s Model list of Essential Medicines. They substantially reduced the viral load in the upper respiratory tract. Raoult teamed up with Dr. James Todaro, Beaumont Hospital, Dearborn, Michigan. (71a Ibid, 29) on South Korean and Chinese studies which confirmed the effectiveness of treatment...claiming 100 % cure rate.

On March 18, 2020 Chinese research team published a study in Nature showing hydroxychloroquine is effective in inhibiting SARS-CoV-2 infection in vitro. Prior studies in India, France, South Korea and China confirmed the same. (72. Ibid, 39).

On March 19, 2020, President Trump mentioned chloroquine and hydroxychloroquine as potential game changers in the fight against COVID-19 (73. Ibid)) The Washington Post Editorial Board wrote, “Trump is spreading false hope for a virus cure-and that’s not the only damage.” The Post pushed the pharmacies’ vaccine narrative and also dismissed Dr. Raoult’s work of one of the world’s greatest scientists. The Washington Post is owned by Amazon founder Jeff Bezos whose corporation profited enormously as a result of the pandemic.

Dr. Rick Bright (74. Ibid, 62) was ousted by President Trump as Director of the Biomedical Advanced Research Development Authority (BARDA) in the United States Department of Health and Human Services because he sabotaged the Presidents Executive Order to make the national stockpile of hydroxychloroquine available to the public but instead maneuvered to restrict

distribution to only hospitalized patients. Hospitals, however, were under instruction not to administer it to Covid-19 patients.

BARDA was interested in vaccine development and along with Fauci's NIAID a major funder of Moderna's mRNA vaccine against COVID 19. Before Bright left BARDA he oversaw a transfer of \$483 million from BARDA to Moderna to develop its mRNA vaccine. Fired from BARDA by President Trump, Dr. Bright quickly had a new job as the CEO of Rockefeller Foundation Pandemic Prevention Institute and Senior VP of its Pandemic Prevention & Response.

At the same time Dr. Bright was undermining the promotion of Hydroxychloroquine, NY Gov. Cuomo issued executive orders which prohibited NY pharmacies from filling off-label prescriptions for COVID patients (75. Ibid, 67) and sent thousands of elderly sick hospital patients into nursing homes without repurposed safe and effective medicines. (76., Ibid,69).

42% of all COVID deaths in the US had occurred in nursing homes, assisted living facilities, and other long-term care facilities. (77. Ibid 57)

On June 2, 2020, USA Today reported, "Over the last 3 months, more than 40,600 long term care residents and workers have died of COVID 19, about 40% of the Nation's toll attributed to COVID-19 virus. (78. Ibid, p 70) The hydroxychloroquine treatment, unfortunately was not available to them.

JAMA Study that included 5,700 patients hospitalized with COVID in NYC area between Mar. 1, 2020 and Apr. 4, 2020 mortality rates for those who received mechanical ventilation ranged from 76.4 % to 97.2 % depending on age. (79. Exhibit 5, p.57)

Dr. Risch stated that ½ the Covid deaths in New York and 1/3 in nation occurred in nursing homes. (80. Exhibit 2, p.9)

Monoclonal antibodies should have been given nursing homes according to Dr. Harvey Risch but they were made scarce. But even more so, ivermectin and hydroxychloroquine should have been used

Dr. Harvey A. Risch, professor of epidemiology at Yale School of Public Health July 23, 2020 Newsweek op-ed he wrote, "I have authored over 300 peer-reviewed publications and currently hold senior positions on the editorial boards of several leading journals. I am usually accustomed to advocating for positions within the mainstream of medicine, so have been flummoxed to find that, in the midst of a crisis, I am fighting for a treatment that the data fully support but which for reasons have nothing to do with a correct understanding of the science, has been pushed to the sidelines. As a result, tens of thousands of patients with COVID-19 are dying unnecessarily... I am referring, of course to the medication hydroxychloroquine. When this inexpensive oral medication is given very early in the course of illness, before the virus has had time to multiply beyond control, it has shown to be highly effective, especially when given

in combination with the antibiotic's azithromycin or doxycycline and the nutritional supplement zinc." (81. Exhibit 5, p.124)

Doctors successfully treating patients with repurposed medicines were attacked by the medical establishment itself.

Dr. Paul Marick has over 500 peer-reviewed articles and was Professor of Medicine, Chief of Pulmonary and Critical Care Medicine at East Virginia Medical School. At his hospital the treatment of Covid with Vitamin C was banned and his career was ended by a sham peer review reminiscent of an inquisition without a semblance of due process. He was shamelessly bullied and railroaded. He used a similar treatment protocol as Dr. Peter McCullough.

Dr. Peter McCullough one of the most outstanding physicians in the United States was also the Vice Chief of Internal Medicine and Program Director of Cardiology at Baylor University Medical Center in Dallas. He lost his employment at Baylor also as well as other universities where he taught as a professor. He is the most published author in history in area of cardio-renal medicine and stressed that doctors were allowed to prescribe off-label drugs for every other condition except for Covid-19, which is a perfectly safe medicines having been established by billions of doses taken...What was harm to offer them when nothing else was being offered? (82. Exhibit 4, p.96)

"We don't know what's happening in our world" Dr. McCullough explained, "My YouTube videos about early treatment were taken down and then my planned WebEx conference with the Australian MP about treatment was hacked. Now my hospital administrators are acting like I'm out of line for accepting a U.S. Senator's invitation to testify about the disease. It's as though, for the first time in history, our medical system is opposed to caring for the sick. What on earth is going on." (83. Exhibit 4, p.147)

Senator Ron Johnson said, "To me it is obvious that we should explore every possibility for treating this disease at every stage. Why has there been such resistance to low cost, off the shelf therapies that might stop the progression and help keep people out of the hospitals and intensive care units? I hope today's hearings can answer that question and help to correct this glaring blunder that has cost far too many lives." (84. Ibid p.51)

Dr. Meryl Nass, an internal medicine physician with over 40 years experience and expert in bioweapons had her license suspended in Maine by state Board of Licensure for treating patients with Hydroxychloroquine and Ivermectin and is involved in state hearings to get it reinstated

Drs. Pierre Kory and Umberto Meduri at FLCCC were also stripped of their positions. Dr. Kory is a critical care physician and co-founder of Front Line COVID-19 Critical Care Alliance (FLCCC) who twice recently testified before the United States Senate Committee regarding COVID-19

In France Prof. Didier Raoult, one of France's most outstanding physicians suffered harassment and is facing ethics charges for using hydroxychloroquine as a coronavirus treatment.

Drs. Ryan Cole, Simone Gold, Brooke Miller and Mary Talley Bowden were fired or lost hospital privileges because of their positions on COVID treatment. Independent Drs. like Vladimir Zelenko, Ivette Lozano, George Fareed and Richard Urso were harassed by state medical boards and vilified by the media all for the crime of early treatment of COVID-19 with drugs that had long been FDA approved for other conditions. (89. Exhibit 4 p. 241).

Dr. Peter McCullough wrote, "70% of the nation's COVID-19 fatalities could have been prevented., that came to 610,000 preventable deaths. In light of this disturbing reality, the actors who organized the propaganda campaign against early treatment and who deliberately hindered sick people from receiving medicines should be under investigation for mass negligent homicide. (90. Ibid, p.257) You have a duty to try to help the person with whatever is at hand."

By autumn of 2020 there were more than 200 studies supporting treatment with Hydroxychloroquine and 60 studies supporting Ivermectin.

The suppressed common-sense treatments were proof that the medical establishment has an ulterior motive. A mendacious medical technocracy is implementing a biologic- terrorism on doctors who cared for their patients' health and provided life-saving treatments.

Hydroxychloroquine showed in a NIH study in 2005 as a potent inhibitor of SARS corona virus infection and also inhibits influenza.... This is a threat to drug industry, designer viruses.

Dr. Robert Malone who is the inventor of the mRNA gene therapy delivery system stated in his book, **"Lies My Government Told Me"** That he was shocked to find out that the Government already knew of options for treatment of COVID-19 before it appeared, but instead of trying to identify safe, cheap and available repurposed drugs to address the illness, it used harmful experimental vaccines.

Not only did chloroquine work in vitro against MERS corona virus but dozens of existing drugs were also effective as mentioned in a 2012 Journal article, **“Antimicrobial Agents and Chemotherapy” “Repurposing of Clinically Developed Drugs for Treatment of Middle East Respiratory Syndrome Coronavirus Infection”** NIAID wrote,

“Here we found 66 of the screened drugs were effective at inhibiting either MERS-Cov or SARS-CoV infection in vitro and that 27 compounds were effective against both MERS-CoV and SARS-CoV. These data demonstrate the efficiency of screening approved or clinically developed drugs for identification of potential therapeutic options for emerging viral diseases and also provide an expedited approach for supporting off-label use of approved therapeutics.” (91. Exhibit 7)

Now Fauci’s NIAID was doing the exact opposite.

In an attempt to place a pall over Hydroxychloroquine and protect Gates’ vaccine interest, a sabotage of an earlier study of hydroxychloroquine, Recovery Trial was done by intentionally over dosing sick patients with 2,400 mg of hydroxychloroquine 3 to 6 times higher than the daily dose and the same ruthless deceit and manipulation was conducted with the Solidarity Trial lead by the WHO (92. Exhibit 5, p. 125). Trials were sabotaged and innocent people sacrificed.

Millions of individuals were sickened and thousands died, but remarkably the survival rate for COVID-19 was 99.22 % for those unvaccinated who tested positive. Most of the Covid victims were elderly in their late 70’s and 80’s with 3.5 co-morbidities. And even for those elderly who got Covid the survival rate was very high. Ironically, flu which was the usual killer of the elderly and sick seemed to disappear during this time and the overall death rate seemed to go down from the previous year.

Do we really need a COVID-19 vaccine? Covid mortality was extremely low outside nursing homes. 99.7 % of people infected recovered. If under 60 years of age, one’s chance of dying from influenza is greater than Covid-19.

CDC survivability rate is 99.997 percent for 0-19 years, 99.98 percent for 20-49 years, 99.5 percent for 50-59 years and 94.6 percent for 70 – plus years. (93. ibid p. 68).

Natural immunity in all cases is superior to vaccine induced immunity. (94. Exhibit 2, p.8) but the WHO stressed vaccine immunity.

Informed Consent one of the foundations of modern medicine has been stymied by FDA, NIH, CDC, hospitals, big tech, and social media. **(95. Exhibit 7, p.24)**

**ANTHONY FAUCI, BILL GATES AND THE ENTERPRISE COMMITTED MEDICAL FRAUD WHEN THEY REPRESENTED THAT THEIR VACCINES AND THE DRUG REMDESIVIR WERE SAFE AND EFFECTIVE TREATMENT FOR COVID WHEN THEY WERE NEITHER.**

**CREATION OF SECOND BIOWEAPON:**

Fast tracked, experimental mRNA, researchers have been trying to develop a corona virus vaccine since acute respiratory syndrome (SARS-1) outbreak in 2002. mRNA had never been licensed for use in humans. (96. Exhibit 5, **The Truth About Covid-19**, Joseph Mercola, Ronnie Cummins, Chelsea Green Publishing, 2021, p. 129) “To expect these experimental fast-tracked coronavirus vaccines to succeed when others that have been tested over far longer periods of time have failed miserably is pure folly.” (96. **Ibid p.128**)

Dr. Anthony Fauci and Bill Gates are two faces of the same Enterprise, both are front men for not only the pharmaceutical companies but for other wealthy and powerful interests. Gates is listed as one of the wealthiest men on earth with a net worth of \$129 Billion.

Fauci’s salary before recently retiring as director of the National Institute of Allergy and Infectious Disease was the highest government salary in the United States at \$417, 608.00 and that does not include bonuses and other interests he has. Fauci controlled \$6 billion dollars of research money which allowed him to control and direct 1,200 loyal private investigators, (PI) university scientists and researchers to work on projects he oversees. He and the PIs can also earn up to \$150,000 annually on new drugs and vaccines. Fauci’s, emphasis was always given to creation of new vaccines as that was where the money is. He also received as NIAID head \$1.7 Billion from DARPA since 2005. (97. Exhibit 2, p.118).

Fauci has 8 patents listed to his name as inventor. He also has close ties to Moderna. (97. **Ibid p.121**). DARPA, the Defense Advanced Research Projects Agency, contributed \$56 million to Moderna vaccine development (98. Exhibit 1, p. 17). Gates also has keen interests in Moderna.

Anthony Fauci recalled a story of when Bill Gates invited him to his mansion, “Melinda was showing everyone on a tour of the house, and he said, Can I have some time with you in my library...and it was there that he said, “Tony, you run the biggest infectious disease institute in the world. And I want to be sure the money I spend is well spent. Why don’t we really get to know each other? Why don’t we be partners? (99. Exhibit 4, p.261). Fauci presently sits on the leadership council for the Bill and Melinda Gates Foundation.

Partnership between Gates and Fauci and Welcome Trust control somewhere around 57% of global biomedical research funding. Gates Foundation wields vast influence in mass media. \$250 million of Gates Foundation grants to radio and television newsrooms, including \$17.5 million to NPR alone newspapers, journalism organizations, and advertising firms to create content. (100. **Ibid**, p. 261)

**Who is Bill Gates?** James Corbett answers that question in detail in his full 2020 documentary video <https://www.corbettreport.com/who-is-bill-gates-full-documentary-2020/> (100a. Exhibit 44)

Fauci and Gates have a history of suppressing old but effective generic drugs in order to promote new, commercially valuable medications. (101. Ibid p.262)

Fauci has an army of PIs that dominate public health policy for him and act as lobbyists, enforcers, powerful academic physicians and researchers who use federal grants and pharmaceutical contracts to build feudal empires at university & research hospitals that mainly conduct clinical trials, key stage in licensing process determining direction of biomedical research. Dogma. Censorship flows from this kind of concentrated power (102. Exhibit 2, p.136)

RFK Jr. wrote, “You’re going to see a lot of people dropping dead. The problem is, Anthony Fauci put \$500 million of our (tax) dollars into that vaccine. He owns half the patents. He has five guys working for him (who are) entitled to collect royalties. So, you have a corrupt system, and now they’ve got a vaccine that is too big to fail. They’re not saying this was terrible, terrible mistake, they’re saying, “We’re going to order 2 million doses of this (vaccine)” ...And they have no liability...No medical product in the worlds would be able to go forward with a (safety) profile like Moderna has.” **(103. Exhibit 5, p.142)**

An Open Letter to the WHO was written by Geert Vanden Bossche, DMV, PhD, independent virologist and vaccine expert, formerly employed at GAVI and The Bill & Melinda Gates Foundation imploring the immediate halt to all Covid-19 Mass Vaccinations ”( 104. Exhibit 42) <https://fos-sa.org/2021/03/12/open-letter-to-the-who-immediately-halt-all-covid-19-mass-vaccinations-geert-vanden-bossche-dmv-phd/>

This is a letter from a world recognized vaccine expert, directed to all authorities, scientists and experts around the world, to halt all vaccinations.

For Federal Drug Administration (FDA) to issue an Emergency Use Authorization (EUA) there must be no adequate approved and available alternative to the candidate product for diagnosing, preventing or treating the disease or condition...” (105. Exhibit 2, p.19).

As was presented in Point II, there were two wonder drugs as well as other medicines which would have saved hundreds of thousands of people’s lives that were inexpensive and safe.

However, Emergency Use Authorization, (EUA) from Big Pharma perspective is the preferred way to market their drugs. The advantages: single purchaser, provides complete liability indemnification, guaranteed market, with very little oversight, and manages both distribution and marketing. Government markets unlicensed products and coordinates with corporate media, social media, and large technology firms to suppress discussion. (106. Exhibit 7, p.118)

The first confirmed case of COVID 19 in US. was reported in mid-January 2020. Vaccines were not available until middle of December 2020 when FDA granted Emergency Use Authorization (EUA) for Pfizer-BioNTech and Moderna, and in February 2021 to Johnson & Johnson/Janssen vaccine

On October 22, 2020 Remdesivir (Veklury) became the first COVID treatment to receive EUA approval from the FDA. It is administered only in hospitals with IV drip.

On December 11, 2020 Pfizer-BioNTech was first COVID-19 vaccine authorized under EUA

On December 18, 2020 Moderna vaccine was authorized under the EUA.

February 27, 2021 Johnson & Johnson vaccine received EUA authorization.

Gate's CEPI's business plan went into effect when SARS-CoV-2 arrived. Gates and Fauci and their network proclaimed there were no treatments and that everyone needed to stay home until vaccines were deployed and every human on earth received them. Vaccines were presented as the panacea to a global emergency, those who developed the vaccines received the following advantages: 1. Massive emergency R&D funding from government treasuries 2. Massive purchasing commitments from the same government. 3. Zero product liability 4. Zero marketing costs. 5. An absolute global market (every man, woman, and child on earth) 6. A recurring revenue stream from regular booster shots. (107. Exhibit 4, p.264)

The social pressure mounted...Get vaccinated! Eliminate any competitors that could diminish the perceived urgent need for new vaccines, Hydroxychloroquine and Ivermectin were relentlessly maligned. Monoclonal antibodies were also suppressed. Suppressing treatment was equivalent of disarming the people and leaving them defenseless.

#### **APPENDIX 1. LIST OF ADVERSE EVENTS OF SPECIAL INTEREST.**

Vaccines were mandated as the only acceptable treatment for Covid-19, and for hospital patients, remdesivir and mechanical ventilation was the standard treatment. The very safe, effective and low cost federally approved medications were not sanctioned. Millions of doses of vaccines were distributed, but after the administering of vaccinations sickness and death rates began to soar instead of decline. #### **The Oregon VAERS (Vaccine Adverse Event Reporting System) report through February 23,2024:**

**Indicated that in Oregon 94 deaths resulted from the vaccines as well as, 301 permanent disabilities, 289 life threatening reports, 577 hospitalized, 125 myocarditis, and 47 anaphylaxes. Realizing that only 1% to 10% of the adverse reactions are being reported, Oregon could be suffering up to 9,400 deaths, 30,100 permanent disabilities and 28,900 life threatening incidents. The VAERS statistics need to be followed up on by an investigation into the reported serious injuries and deaths represented to be caused by the vaccines. In the US as of October 17, 2022, 265.59 million US residents have received at least one dose, and 226.59 million have completed the initial vaccination protocol out of a total population of 335.59 million (67.5%). Of the 613.25 million mRNA doses administered 375.64 million were manufactured by Pfizer Bio/NTech, and 237.61 doses by Moderna, (118. Exhibit 7, p.117)

A. Pfizer executive confirmed that vaccine has never been tested for its ability to prevent transmission of SARS CoV2 before putting it on market. There are no studies. (119. Ibid 82)

What was responsible for all of the adverse effects the vaccines were causing

Why were these alleged vaccines killing people and making them sick? Despite the injuries why are the vaccines still being marketed and sold?

The vaccines were not regular standard vaccines, but touted as an experimental gene therapy. According to Dr. Francis Boyle who drafted the Biowarfare Anti-terrorist Act which was unanimously approved by Congress and who wrote a book entitled, **“Resisting Medical Tyranny”**, they are bioweapons violating the Federal Act. He calls them **“Frankenshots”**. These injections also violate Federal statute 18 USC 175 as a bioweapon. (120. Exhibit 3) and (121. The vaccines (Kill Shots) contain: mRNA vaccines and incorporate a synthetic nucleotide called pseudouridine that can stay in glands at least 60 days after injection, and perhaps much longer. Incorporation of this molecule into the synthetic mRNA may well account for observed immunosuppression. (122.Exhibit 7, p.124)

The spike protein involved with toxic Polyethylene glycol used to coat mRNA and spike protein itself with the pseudouridine which causes cells to manufacture adverse events can also be toxic and one of the most toxic molecules ever used for vaccinations. Spike is a toxin which moves throughout the body and crosses the Blood/Brain barrier. There are no studies beyond 60 days as to how long it stays in one's body and causes internal organ damage. (123, ibid, p.126)

Independent scientists, researchers and doctors began to closely examine the patents and contents of the vaccines with sophisticated equipment which could see a nanoworld, invisible to the naked eye and found many disturbing items in addition to spike protein ranging from parasites, HIV remnants, graphene oxide, heavy toxic metals, nano material, self-assembling

polymers with cables/ribbons connecting to portals, microchips, snake peptides., quantum dots, programmable hydrogel and heavy nanosized metals. What kind of experimental mRNA spike protein vaccine had been concocted? Something out of the Twilight Zone...but real. "What is in the so-called COVID-19 "Vaccines"? Point II above shows there were excellent repurposed medicines which would have effectively and safely protected the public and made the need for a EUA for untested vaccines unnecessary. The Enterprise, however, was not concerned with the best interests of the Public. They wanted to vaccinate as many people as possible with an experimental untested gene therapy.

Bill Gates has always had the desire to vaccinate every person on earth. Covid-19 served as the perfect public nemeses for an announcement that only one thing would allow us to go back to normal and that was fast-tracked vaccines. Gates was insistent on lightning-fast development and deployment and the need for a consistent nation-wide policy pertaining to shutting down society and the building of vaccine factories, (125. Exhibit 4, p.42))

To echo Dr. Mercola once more, "To expect these experimental fast-tracked coronavirus vaccines to succeed when others that have been tested over far longer periods of time have failed miserably is pure folly." (126. Exhibit 5 p. 128)

Are lipid nanoparticles safe? Are there risks of autoimmune challenges? (127. Ibid p. 133), Are there risks to antibody dependent immune enhancement, when a viral vaccine renders one more prone to severe disease and death if subsequently you are infected with the virus

whipping up a cytokine storm within you. (128. Ibid p.133-34) increasing the risks of anti-body-dependent enhancement aka paradoxical immune enhancement ...: Vaccines for SARS, MERS, and RSV have never been approved, and the data generated in the development and testing of vaccines suggest a serious mechanistic concern. Vaccines designed empirically using the traditional approach, consisting of the unmodified or minimally modified coronavirus viral spike to elicit neutralizing antibodies, be they composed of proteins, viral vector, DNA or RNA and irrespective of delivery method, may worsen COVID-19 disease via antibody-dependent enhancement (ADE)” (129. Ibid p.134)

When ferrets were experimented on with vaccines as a result of the SARS epidemic, 30 vaccines had been considered. The best four vaccines were tested. The ferrets had good antibody response. But when exposed to the wild virus all the ferrets developed inflammation in all the organs, their lungs stopped functioning. And they all died. (130, Ibid p.135)

Dr. Peter Breggin quote,” ...these injections bear no resemblance to anything else in human history that has ever been called a vaccine. They most nearly resemble a Trojan horse.” (131. Exhibit 1, p.175)

The vaccines use genetic instructions copied from SARS-CoV-2 which enable the deadly virus to make the spike protein that gains entry into the human cells and is known to be very toxic to mammals, including humans. (132. Ibid p.176)

Among other harmful effects it damages the endothelial cells in many organs of the body and in the blood cells, this can cause bleeding and clotting, and even death, also severe immunological overreactions, leading potentially to a cytokine storm seen in COVID -19. Nanoparticle polyethylene glycol (PEG) sealer is put around the messenger RNA to package and protect it in the human body before it enters the cell.

Dr. Peter McCullough wrote, “Never before have we used technology where we trick our own bodies to make dangerous protein which is a laboratory product of bioterrorism research.

In Israel, based on Ministry of Health data, an independent scientist found more deaths from the mRNA vaccines than from COVID-19 and described it as a new Holocaust. (133. Ibid p.178)

Because the mRNA and DNA interfere with the cellular regulatory mechanism called RNA, myriad unexpected adverse reactions are possible. These vaccines are essentially priming the immune system, while providing it a SARS-CoV- LIKE SPIKE PROTEIN AS AN INTERNALLY CREATED ALIEN SUBSTANCE FOR THE IMMUNE SYSTEM to attack.

There is a safety concerns regarding experimental COVID-19 vaccines: 1, brand new technology, 2. failure of previous corona virus vaccines, 3. No independently published animal studies, 4. Known complications, 5. Unknown complications, 6. Pharmaceuticals are immune from all liability, 7. An experimental vaccine is not safer than medications such as Hydroxychloroquine

and Ivermectin. No proof vax stops transmission, unknown mortality or hospital admission benefit, unknown vaccine duration. (134. Ibid 194)

What was responsible for all of the adverse effects the vaccines were causing

In response to a Freedom of Information Act, Northern District of Texas U.S. District Judge Mark T. Pittman ordered the FDA to release all of the data it relied on to grant the license to Pfizer's COVID-19 vaccine at a pace of 55,000 pages/month. The first batch of documents indicates that Pfizer was aware of 1,291 adverse side effects from its vaccine when it applied for FDA approval. (M54) The FDA had attempted to keep the records secret for 75 years and requested a release of only 500 pages a month. A Billion dollar organization arguing poverty did not impress the judge. (135. Exhibit 16)

Arron Siri, Esq. represented the group of scientists and medical researchers suing and wrote the following

Fully vaccinated are more likely to get COVID. (136. Exhibit 7, p.129) according to Dr. Robert Malone, an internationally recognized scientist/physician and the original inventor of the mRNA and DNA vaccination resulting in 9 issued patents as well as mRNA and DNA based gene therapy (137. Ibid, p.1)

In a public statement at the Washington DC. Defeat the Mandates Rally January 23, 2021, he said, **"genetic vaccines don't work and are not completely safe, vaccines do not protect against Omicron infection, viral replication or spread to others...vaccines are leaky, have poor durability can not achieve herd immunity and stop COVID. Not completely safe and their full risks are unknown."**(138. Ibid p130). This is the man responsible for the mRNA gene therapy patent which comprises the COVID vaccine. He said they don't work.

"As a person who spent his whole professional career in pharmaceutical and vaccine development, I found the whole concept of going from scratch to ready use vaccine in a few months simply preposterous." Dr. Malone continued,

"The CDC is withholding key data. If CDC released the age-stratified data from COVID it would be clear that a vaccine is not necessary for most if not all Americans. If the vaccine risk ratio of those vaccinated and hospitalized were published for Omicron, it would be clear that the vaccine benefit is not observed. The FDA has not revealed what the efficacy of the boosters for children is. They have not released the safety data. They have withheld the safety data on the vaccines for children and adults." (139. Ibid, p.131)

Robert F. Kennedy Jr. writes in his book, **"The Real Anthony Fauci", (140. Exhibit 2)** The final summary of Pfizer's 6-month clinical trial data the document Pfizer submitted for approval revealed one key data point that should have killed the intervention forever. Far more people

died in the vaccine group than in the placebo group during Pfizer's clinical trials. The fact that the FDA nevertheless granted Pfizer full approval, and that the medical community embraced and prescribed this intervention for their patients, is eloquent testimony of even the most deadly and inefficacious products, and the breathtaking power of the pharmaceutical industry and its government allies to control the narrative through captive regulators, compliant physicians, and media manipulation, and to overwhelm the fundamental common sense of much of humanity."

The bastion of free speech, the New York Times censored RFK Jr's book **"The Real Anthony Fauci"**

Millions of doses of vaccines were distributed, but now sickness and death rates began to soar instead of decline. The touted experimental gene therapies ("vaccines") did not protect against infection nor did they protect against transmission as admitted by a Pfizer Executive.

Those who were vaccinated were most likely now to get Covid and end up in the hospital sick with Covid.

The Robert Kennedy Jr. quote should be repeated.

**In 1976 US regulators pulled the swine flu after it was linked to 25 deaths. In contrast between December 14 and October 1, 2021 American doctors and families reported more than 16,000 deaths and a total of 778,685 injuries to VAERS, while European Surveillance Sites reported 40,000 deaths, 2.2 million adverse reactions. (141. Exhibit 2, RFK p. 87) But not in the case of COVID-19, were vaccines halted, instead the vaccines kept on coming, booster after booster.**

**In just 8 months COVID vaccines have injured and killed far more Americans than all other vaccinations combined over 3 decades. (142. Ibid p.88) 69.8% of the deaths occurred during 2 weeks after vaccinating, 39.38 % within 24 hours of injection.**

Covid vaccines are 98% more likely to kill a person than flu vaccine. (143. ibid p.88) Immune protection drops off after 2 months, teen deaths among 15-19 yrs. have increased 47% in UK (140. Ibid, p.92)

Dr. Meryl Nass wrote in her Substack newsletter, **"It's Official! CDC and UK government data reveal the COVID vaccines do not prevent cases, transmission, severe illness or deaths,"** (144. Exhibit 51) <https://merylnass.substack.com/p/its-official-cdc-and-uk-government>

An Israeli study of health workers found that after four doses, the Pfizer vaccine was only 30% effective against Omicron while adverse reactions were 80% of those who received vaccinations. Moderna vaccine was found to be 11% effective while adverse reactions were 40%. (145. Exhibit 7, p..200)

Dr Ryan Cole board certified pathologist who runs a diagnostic lab has seen a twenty-fold increase in endometrial cancers over what he sees on an annual basis. He has also seen an increase in melanomas and a significant increase in human papillomavirus when looking at cervical biopsies of women, and an increase in herpes and shingles infections. (146. Ibid p, 201)

Dr. Peter McCullough in sworn expert witness declaration filed in the U.S. District Court for the Middle District of Florida on October 15, 2021, “The COVID-19 genetic vaccines (Pfizer, Moderna, J&J) skipped testing for genotoxicity, mutagenicity, teratogenicity, oncogenicity. In other words, it is unknown whether or not these products will change human genetic material, cause birth defects, reduce fertility, or cause cancer.” (147. Ibid, p.124)

Dr. Michael Yeadon, former vice president and chief science officer at Pfizer, who denounced the toxic vaccine, cited a study that found significantly elevated levels of antibodies against the placenta following administration of Pfizer- BioNTech COVID-19 vaccine. (148. Ibid 204)

On June 25, 2021 the FDA announced revisions on Fact Sheets for Pfizer-BioNTech and Moderna COVID-19 vaccines adding a warning about the “increased risk of myocarditis inflammation of heart muscle, permanent heart damage, and pericarditis (inflammation of tissue surrounding the heart) following vaccination also a revision for J&J/Janssen COVID-19 warning of increased Guillain-Barre syndrome following vaccination which could cause paralysis without a cure. (149. Ibid, p.205).

National Childhood Vaccine Injury Act, 1986 shielded all mandated vaccines from liability. (150. Exhibit 2, Kennedy p. 360)

Flashbacks occur from the early 1980’s of disease paranoia. For Fauci, then, AZT is to HIV as Remdesivir, now, is to COVID-19. (151. Ibid, p.122) Robert Kennedy Jr. points out in his book that a similar pharmaceutical template is being used with Remdesivir, that had previously been deployed with the extremely toxic AZT, used for those suffering from HIV. “A disturbing but similar pattern to what is portrayed with COVID urgency also happened with HIV AZT and trials. Dr. Frank Ruscetti, top virologist working under Robert Gallo stated, **“We could have saved millions of lives with repurposed and therapeutic drugs. But there is no profit in it.** It’s all got to be about their newly patented antiviral and mischievous vaccines. **Fauci refused to test repurposed drugs.** (152. ibid, p.162) AZT was killing more people than AIDS (1503ibid 170). Dr. Peter Duesberg, a brilliant molecular biologist accused Fauci of mass murder by using AZT. (154. ibid p.179). Kary Mullis, founder of the PCR test stated that HIV virus was never isolated. (155. Exhibit 17) <https://rumble.com/vhu4rz-kary-mullis-inventor-of-the-pcr-test.html> and thought Fauci was a scoundrel.

WHO ordered Nations, hospitals and MDs (156. Exhibit 2, p.30) to stop using Hydroxychloroquine on 6/15/2020. The only hospital treatment was Remdesivir which both Fauci and Gates were heavily invested in.

If an individual had the misfortune to need hospitalization Remdesivir, was Dr. Fauci's protocol. It had no clinical efficacy against Covid. Worse, it is deadly poisonous and expensive, 1000 times more expensive than Hydroxychloroquine and Ivermectin. (157. Ibid p.63) NIAD and CDC spent \$79 Million developing Remdesivir for Gilead a company of which Bill and Melinda Gates Foundation owns \$6.5 Million (158. ibid p.63).

Hospital protocols for treatment of Covid-19 patients. were the use of toxic remdesivir and lung damaging ventilators. Hydroxychloroquine and Ivermectin use for Covid-19 treatment was banned

Fauci designed a flawed randomized blind placebo-controlled studies for Ivermectin but not for Remdesivir where there was no placebo in the control groups. (160. Exhibit 2, Kennedy, p.65). Gilead's Remdesivir costs \$10/dose to make and then it charges \$3,120.00 for a 5 dose Remdesivir treatment. It brought in \$3.5 Billion alone in 2020. (161 Ibid, p.64)

*The Lancet* published a study from China that showed that Remdesivir was toxic. It did not reduce the presence of virus in the blood, and was totally ineffective in keeping hospitalized patients alive. Fauci actually manipulated and lied about the various Remdesivir studies and said he wanted to make Remdesivir available to the public as it would be unethical to deprive them of it. (162. Ibid, p.66) The China studies of Remdesivir showed liver and kidney damage to the recipients.

WHO remarkably was against Remdesivir Emergency Use Approval (163. Ibid, p.68) Remdesivir had a history of failure during an Ebola study, 6 months into study the trials Safety Review Board pulled Remdesivir out of the study. Within 28 days, subjects taking Remdesivir had lethal side effects including multiple organ failure, acute kidney failure, septic shock, and hypotension, and 54% of the Remdesivir group died. The highest mortality rate of the four experimental drugs being tested.

In the Remdesivir Ebola study, the toxic drug, kills and injures people, in less than 5 days, 8% of people died and 31 % had acute kidney failure. (164. Ibid, p.70) It causes extreme toxicity in lungs and kidney, multi organ failure. (165 Ibid, p.69)

Dr. Mccullough summarized, "Remdesivir has two problems. First, it doesn't work. Second, it is toxic and kills people". (166 ibid)

Based on Fauci's recommendation President Trump bought 500,000 doses of Remdesivir. Gilead received \$85 million. Fauci, Gates and the Enterprise prospered.

### 3.False Information and Hoaxes: 18 U.S.C 1038

**ANTHONY FAUCI, BILL GATES AND THE ENTERPRISE KNOWINGLY AND INTENTIONALLY GAVE FALSE AND MISLEADING INFORMATION WHERE SUCH INFORMATION WAS REASONABLY BELIEVED AND RELIED UPON CONCERNING AN ACTIVITY TAKING PLACE INVOLVING A VIRUS, IT'S SPREADING, LOCKDOWNS AND VACCINES WHICH INVOLVES AND CONSTITUTES A VIOLATION OF CHAPTER 10 BIOLOGICAL WEAPONS, CHAPTER 11B CHEMICAL WEAPONS AND CHAPTER 113B TERRORISM**

(a) Criminal Violation. —

(1) In general.—Whoever engages in any conduct with intent to convey false or misleading information under circumstances where such information may reasonably be believed and where such information indicates that an activity has taken, is taking, or will take place that would constitute a violation of chapter 2, 10, 11B, 39, 40, 44, 111, or 113B of this title, section 236 of the Atomic Energy Act of 1954 (42 U.S.C. 2284), or section 46502, the second sentence of section 46504, section 46505(b)(3) or (c), section 46506 if homicide or attempted homicide is involved, or section 60123(b) of title 49, shall—

(A) be fined under this title or imprisoned not more than 5 years, or both;

(B) if serious bodily injury results, be fined under this title or imprisoned not more than 20 years, or both; and

(C) if death results, be fined under this title or imprisoned for any number of years up to life, or both.

This crime of giving false information and hoaxes will apply to the Sections herein on bioweapons, fraud, domestic terrorism and murder. **4. Domestic Terrorism: USA Patriot Act, 18 USC 2331 (5), 18 U.S. Code Chapter 113B, ANTHONY FAUCI, BILL GATES AND THE ENTERPRISE COMMITTED AN ACT OF DOMESTIC TERRORISM IN VIOLATION OF THE USA PATRIOT ACT SECTION 802 (PUB.L), and Crime of domestic terrorism, 18 USC 2331 (5) and Oregon Criminal Statutes 165.125**

(5) the term “domestic terrorism” means activities that— (A) involve acts dangerous to human life that are a violation of the criminal laws of the United States or of any State; (B) appear to be

intended— (i) **to intimidate or coerce a civilian population**; (ii) to influence the policy of a government by intimidation or coercion; or (iii) to affect the conduct of a government by mass destruction, assassination, or kidnapping; and (C) occur primarily within the territorial jurisdiction of the United States; and

Dr. Fauci, Bill Gates and the Enterprise Committed an Act of Domestic Terrorism in violation of the, 118 USC 2331 (5,) USA Patriot Act Section 802 (Pub. L. No. 107-52) and Oregon criminal statute. Terrorism consists of committing an act dangerous to human life that is also a criminal violation of state law with the intent to: (1) intimidate or coerce a civilian population, including committing mass violence in a public accommodation when they intimidated and coerced a civilian population by orchestrating unnecessary mandates and lockdowns of the entire Nation with fear of death, loss of jobs and income and panic including the need for masks, social distancing, contact tracing, quarantines, restrictions on travel, work, social activities including going to church, visiting hospitals, attending funerals' etc. creating demoralization and the wrecking of a vibrant economy and threatened, extorted and coerced a population to be unnecessarily vaccinated and continued pressure to vaccinate when there never was an emergency situation other than the paranoia and fear they created while providing no early treatment, leaving the public defenseless for at least 9 months without a treatment protocol causing millions of citizens to be traumatized, seriously injured or die either from the "virus" or the experimental vaccination.

#### **Oregon Criminal Statute 165.125 Domestic Terrorism**

(1) A person commits the crime of domestic terrorism in the first degree if the person, with the intent to cause widespread sickness, contagion, serious physical injury, death or the disruption of services provided by critical infrastructure:

- (a) Intentionally destroys or substantially damages critical infrastructure; or
- (b) Intentionally introduces, releases or disperses a toxic substance into widespread contact with human beings.

(2) Domestic terrorism in the first degree is a Class B felony.

(3) The Oregon Criminal Justice Commission shall classify domestic terrorism in the first degree as crime category 9 of the sentencing guidelines grid of the commission.

ORS 166.125. Added by 2023 Ch. 608, § 2

The American population was **intimated and coerced in many ways** by imposed government mandates and scurrilous actions of various individuals and organizations.

Initiating the fear mongering was Neil Ferguson, a professor at Imperial College in England who had a history of over exaggerating the seriousness of diseases. The Pandemic overseers had different protocol and concerns: How to use police powers to detain, quarantine, impose martial law, how to control messaging by deploying propaganda, and censorship to quiet dissent, how to mandate lockdowns, coerce vaccinations and conduct track and trace surveillance among potentially reluctant populations, contact tracing, now, in real time. #### **PCR TESTS ARE MISLEADING AND NOT INDICATIVE OF COVID INFECTION**

This PCR deception was covered previously in the Fraud: Section 1.b). The PCR tests are not accurate in diagnosing live virus but nonetheless were used to deceptively inflate the numbers of people sick with Covid 19. The inventor of the PCR, Kary Mullis, a Nobel Prize Winner was a staunch opponent of Anthony Fauci and his misuse of the PCR test during the HIV/Aids outbreak and the administration of toxic AZT. He said that the PCR test should not be used in the manner in which Fauci was using it. ## **MASKS DON'T PROTECT AGAINST A VIRUS**

Masks use was contrary to science, but 85 % of covid victims wore masks. (180. Exhibit 2, p.2)

Dr. Fauci flip flopped on the need for masks. You need it. You don't need it. You need to double the mask up. The masks could never be effective because a virus is so small that it easily penetrates the mask. It is not wise to be wearing a mask inhaling constantly one's carbon dioxide which is a waste product. Masks, besides being uncomfortable, are a negative psychological symbol of servitude. They are especially very detrimental to a child's psychology.

D.J. Rancourt stated that there is no compelling evidence to support masks in treatment of respiratory illnesses. (181. Exhibit1, p.199)

Masking ourselves from each other is a hall mark of totalitarian state, according to psychiatrist Peter Breggin (182. Ibid, p.200)

Mandatory mask: effectiveness is weak, cost of wearing masks high, causing and aggravating cardiovascular respiratory illnesses, diminishing social interactions, causing alienation, fostering docility and conformity, and making dictatorial politicians feel they can demand of the citizens ever more submission and forsaking of liberty.

Masks don't work against a virus like Covid-19.

Dr. Fauci acquiesced to CDC's selective protocol changes for completing death certificates in a way that inflated the claimed deaths from COVID and thus inflated the infection mortality rate. CDC later admitted that only 6% of COVID deaths occurred in entirely healthy individuals. The remaining 94% suffered from an average of 3.8 potentially fatal comorbidities. (185. Exhibit 2, p.4)

Quarantine of the healthy would cause far more deaths than Covid. It caused poverty, bankruptcy, loss of life expectancy, suicide, loss of IQ, overdoses, dying alone in hospitals, without comfort.

Unnecessary lockdowns put 58 million people out of work (186. Ibid, p. XXI)

Meanwhile, secret talks between Google, Facebook, Amazon and other tech giants spent a day with the World Health Organization, WHO on how to deal with COVID misinformation. Daily Mail (M153) Fact checkers were being lined up in conjunction with the CDC. (187. Exhibit 7, p.98)

Mark Zuckerberg from Facebook gave \$35 million to the CDC Foundation and to the WHO acting as CDC agent-in-fact in an effort to stamp out so-called COVID “misinformation”.

CDC and Fauci did not like to acknowledge that natural immunity is robust and long lasting and that natural infection provides excellent protection against repeat occurrences (188 Ibid, p.156)

Fauci supported skipping autopsies so the death could not be traced back to the vaccines. He supported vaccines for people who already had Covid and therefore natural immunity and should not have a vaccine and for children for which COVID posed no threat,

Fauci suppressed early effective treatment (189 Exhibit 2, p.5)

Fauci, point man for the Enterprise’s fleecing operation destroyed the Nation’s once booming economy putting 58 million American out of work, permanently bankrupting small businesses including 41% of black owned; it was the **largest upward transfer of wealth in human history. In 2020 workers lost \$3.7 Trillion and billionaires gained \$3.9 Trillion.** (190. Exhibit 2, RFK Jr forward)

In August 2020 Bloomberg reported that more than half of all small businesses owners thought their business would not survive. According to September 2020 economic impact report by Yelp, 163, 335 US businesses closed their doors and of those 60%, a total of 97, 966 businesses were permanent closures. By the end of April 2020, pandemic measures had eliminated half of all Black-owned businesses in the US. (183. Exhibit 5, Mercola, p. 70), Despair, drug overdoses, suicides, domestic abuse, rapes, child sex abuse increased. (191. Ibid. p.71)

A FOIA request by Blaze revealed that the Department of Health and Human Services, (HHS) through the CDC purchased advertising promoting the vaccines from major networks including ABC, CBS, NBC, as well as cable TV news stations FOX News, CNN, and MSNBC, legacy media publications including the New York Post, Los Angeles Times, and the Washington Post, digital media companies like BuzzFeed News, and Newsmax, and hundreds of local newspapers and TV stations. (192, Exhibit 7, Malone p.232)

Take Back Control lockdowns had nothing to do about public health, but appears to have been a smoke screen for the greatest transfer (if not theft) of wealth in world history. The biggest losers are the middle class and low-income earners, especially private business owners as big multinational made record amounts. This is Class Warfare. Frank Clemente, Executive Director of American for Tax Fairness stated, “Never before has America seen such an accumulation of wealth in so few hands.” (193. Exhibit 5, p.154)

We do know that a powerful network of global elites, including Bill Gates, the World Economic Forum (WEF), the World Health Organization (WHO), Big Tech, Rockefeller Foundation and the Pentagon clearly anticipated what was coming, and then consciously took advantage of the crisis by seeding and nurturing their economic, technocratic, totalitarian, anti-democratic agenda. The Covid-19 vaccines which are being promoted throughout the United States and the world as safe and effective are viewed by many medical experts as bioweapons and would be classified as not only chemical and biological warfare agents but as weapons of mass destruction.

#### **5. Murder: 18 USC 1111, and Oregon Revised Statutes § 163.107 (2019)**

#### **18 USC 1111: Murder**

- (a) Murder is the unlawful killing of a human being with malice aforethought. Every murder perpetrated by poison, lying in wait, or any other kind of willful, deliberate, malicious, and premeditated killing; or committed in the perpetration of, or attempt to perpetrate, any arson, escape, murder, kidnapping, treason, espionage, sabotage, aggravated sexual abuse or sexual abuse, child abuse, burglary, or robbery; or perpetrated as part of a pattern or practice of assault or torture against a child or children; or perpetrated from a premeditated design unlawfully and maliciously to effect the death of any human being other than him who is killed, is murder in the first degree. Any other murder is murder in the second degree.
- (b) **Homicide** is the killing of a human being by the act, procurement, or omission of another, death occurring at any time, and is either (1) murder, (2) homicide by abuse, (3) manslaughter, (4) excusable homicide, or (5) justifiable homicide. [1997 c 196 § 3; 1987 c 187 § 2; 1983 c 10 § 1; 1975 1<sup>st</sup> ex.s. c 260 § 9A.32.010.] Excusable homicide: RCW 9A.16.030. Justifiable homicide: RCW 9A.16.040 and 9A.16.050

**Oregon Revised Statutes:**

OR Rev Stat § 163.107 (2019)

(1) "Murder in the first degree" means murder in the second degree as defined in ORS 163.115 which is committed under, or accompanied by, any of the following circumstances:

(a) The defendant committed the murder pursuant to an agreement that the defendant receive money or other thing of value for committing the murder.

(b) The defendant solicited another to commit the murder and paid or agreed to pay the person money or other thing of value for committing the murder.

(c) The defendant committed murder after having been convicted previously in any jurisdiction of any homicide, the elements of which constitute the crime of aggravated murder as defined in ORS 163.095, murder in the first degree under this section, murder in the second degree as defined in ORS 163.115 or manslaughter in the first degree as defined in ORS 163.118.

(d) There was more than one murder victim in the same criminal episode as defined in ORS 131.505.

(e) The homicide occurred in the course of or as a result of intentional maiming or torture of the victim.

(f) The victim of the intentional homicide was a person under the age of 14 years.

(g) The victim was one of the following and the murder was related to the performance of the victim's official duties in the justice system:

(A) A police officer as defined in ORS 181A.355;

(B) A correctional, parole and probation officer or other person charged with the duty of custody, control or supervision of convicted persons;

(C) A member of the Oregon State Police;

(D) A judicial officer as defined in ORS 1.210;

(E) A juror or witness in a criminal proceeding;

(F) An employee or officer of a court of justice;

(G) A member of the State Board of Parole and Post-Prison Supervision; or

(H) A regulatory specialist.

(h) The defendant was confined in a state, county or municipal penal or correctional facility or was otherwise in custody when the murder occurred.

(i) The defendant committed murder by means of an explosive as defined in ORS 164.055.

(j) Notwithstanding ORS 163.115 (1)(b), the defendant personally and intentionally committed the homicide under the circumstances set forth in ORS 163.115 (1)(b).

(k) The murder was committed in an effort to conceal the commission of a crime, or to conceal the identity of the perpetrator of a crime.

(L) The murder was committed after the defendant had escaped from a state, county or municipal penal or correctional facility and before the defendant had been returned to the custody of the facility.

(2)(a) Except as otherwise provided in ORS 163.155 and paragraph (b) of this subsection, the court shall sentence a person convicted of murder in the first degree, who was at least 15 years of age at the time of committing the murder, to life imprisonment. The court shall order that the defendant be confined for a minimum of 30 years without possibility of parole or release to post-prison supervision except as provided in ORS 144.397, and without the possibility of release on work release or any form of temporary leave or employment at a forest or work camp.

(b) The court may sentence the person to life imprisonment without the possibility of parole if the person was at least 18 years of age at the time of committing the murder. The court shall state on the record the reasons for imposing the sentence. A person sentenced to life imprisonment without the possibility of release or parole under this paragraph shall not have that sentence suspended, deferred or commuted by any judicial officer, and the State Board of Parole and Post-Prison Supervision may not parole the prisoner nor reduce the period of confinement in any manner whatsoever. The Department of Corrections or any executive official may not permit the prisoner to participate in any sort of release or furlough program.

(3)(a) For a person sentenced to life imprisonment, at any time after completion of the minimum period of confinement described in subsection (2)(a) of this section, the State Board of Parole and Post-Prison Supervision, upon the petition of a prisoner so confined, shall hold a hearing to determine if the prisoner is likely to be rehabilitated within a reasonable period of time. The sole issue is whether the prisoner is likely to be rehabilitated within a reasonable period of time. At the hearing the prisoner has:

(A) The burden of proving by a preponderance of the evidence the likelihood of rehabilitation within a reasonable period of time;

(B) The right, if the prisoner is without sufficient funds to employ an attorney, to be represented by legal counsel, appointed by the board, at board expense; and

(C) The right to a subpoena upon a showing of the general relevance and reasonable scope of the evidence sought, provided that any subpoena issued on behalf of the prisoner must be

issued by the State Board of Parole and Post-Prison Supervision pursuant to rules adopted by the board.

(b) If, upon hearing all of the evidence, the board, upon a unanimous vote of three board members or, if the chairperson requires all voting members to participate, a unanimous vote of all voting members, finds that the prisoner is capable of rehabilitation and that the terms of the prisoner's confinement should be changed to life imprisonment with the possibility of parole, release to post-prison supervision or work release, it shall enter an order to that effect and the order shall convert the terms of the prisoner's confinement to life imprisonment with the possibility of parole, release to post-prison supervision or work release and may set a release date. Otherwise, the board shall deny the relief sought in the petition.

(c) If the board denies the relief sought in the petition, the board shall determine the date of the subsequent hearing, and the prisoner may petition for an interim hearing, in accordance with ORS 144.285.

(d) The board's final order shall be accompanied by findings of fact and conclusions of law. The findings of fact shall consist of a concise statement of the underlying facts supporting the findings as to each contested issue of fact and as to each ultimate fact required to support the board's order. [2019 c.635 §3; 2019 c.635 §3a]

## **6. 18 U.S.C. § 113 - U.S. Code, Aggravated Assault**

### **ORS 163.185 Assault in the first degree**

(1) A person commits the crime of assault in the first degree if the person:

(a) Intentionally causes serious physical injury to another by means of a deadly or dangerous weapon;

(b) Intentionally or knowingly causes serious physical injury to a child under six years of age;

(c) Violates ORS 163.175 (Assault in the second degree) knowing that the victim is pregnant; or

(d ) Intentionally, knowingly or recklessly causes serious physical injury to another while operating a motor vehicle under the influence of intoxicants in violation of ORS 813.010 (Driving under the influence of intoxicants) and:

(A) In the 10 years prior to the date of the current offense the person has been convicted of at least three of any of the following offenses in any combination:

(I) Driving under the influence of intoxicants in violation of ORS 813.010 (Driving under the influence of intoxicants), or its statutory counterpart in another jurisdiction;

(ii) A driving under the influence of intoxicants offense in another jurisdiction that involved the impaired driving or operation of a vehicle, an aircraft or a boat due to the use of intoxicating liquor, cannabis, a controlled substance, an inhalant or any combination thereof; or

(iii) An offense in another jurisdiction that involved driving or operating a vehicle, an aircraft or a boat while having a blood alcohol content above that jurisdiction's permissible blood alcohol content; or

(B) Intentionally left blank —Ed.

(i) The person has a previous conviction for any of the crimes described in subsection (2) of this section, or their statutory counterparts in any jurisdiction; and

(ii) The victim's death or serious physical injury in the previous conviction was caused by the person driving a motor vehicle.

(2) The previous convictions to which subsection (1)(d)(B) of this section apply are:

(a) Manslaughter in the first degree under ORS 163.118 (Manslaughter in the first degree);

(b) Manslaughter in the second degree under ORS 163.125 (Manslaughter in the second degree);

(c) Criminally negligent homicide under ORS 163.145 (Criminally negligent homicide);

(d ) Assault in the first degree under this section;

(e) Assault in the second degree under ORS 163.175 (Assault in the second degree); or

(f) Assault in the third degree under ORS 163.165 (Assault in the third degree).

(3 ) Assault in the first degree is a Class A felony.

(4) It is an affirmative defense to a prosecution under subsection (1)(d)(B) of this section that the defendant was not under the influence of intoxicants at the time of the conduct that resulted in the previous conviction. [1971 c.743 §94; 1975 c.626 §2; 1977 c.297 §1; 2005 c.513 §1; 2007 c.867 §3; 2009 c.785 §2; 2021 c.480 §5]

In 1976 US regulators pulled the swine flu after it was linked to 25 deaths. In contrast between Dec. 14 and Oct 1, 2021 alone American doctors and families reported more than 16,000 deaths and a total of 778,685 injuries VAERS, European Surveillance Sites 40,000 deaths, and 2.2 million adverse reactions. **(199. Exhibit 2 RFK, p.87).**

**These adverse reactions from the vaccines should be classified criminally as murders for those who died and aggravated assaults for the millions of people seriously injured from the injections**

Dr. Peter McCullough states, "70% of the nation's COVID-19 fatalities could have been prevented., that came to 610,000 preventable deaths. In light of this disturbing reality, the actors who organized the propaganda campaign against early treatment and who deliberately hindered sick people from receiving medicine should be under investigation for mass negligent homicide. (200. Exhibit 4, p.257). You have a duty to try to help the person."

The demonizing of Hydroxychloroquine and Ivermectin allowed for the bioweapon handoff through Emergency Use Authorization from the offensive bioweapon #1, SARS CoV-2, (Severe acute respiratory coronavirus 2), Covid-19 to a full court press bioweapon #2, vaccine roll-out.

The vaccine is far deadlier and sinister than the "virus" or whatever was responsible for making people sick.

Robert F. Kennedy Jr. stated "You're going to see a lot of people dropping dead...Fauci owns half the patents. He has five guys working for him (who are) entitled to collect royalties. So, you have a corrupt system, and now that've got a vaccine that is too big to fail...." (201. Exhibit 5, p.142)

According to data on CDC web site in the US there were 384, 536 deaths attributed to COVID-19 in 2020, before vaccines were made available. In 2021 when vaccines were widely available and mass vaccination campaigns took place, there were 460, 513 deaths attributed to COVID-19 an increase of 19.8 % (202. Exhibit 7, p.192). This indicates that more people died after the vaccines were introduced.

The government has yet to give the public the exact number of deaths from the COVID pathogen, and those from the vaccine which is even greater.

In an article written by Ed Dowd entitled, "Shocking Increases in ALL-Cause Mortality coinciding with COVID Vaccine Mandates"

Dowd writes that on January 2022, Scott Davidson CEO of One America was quoted as saying **"We are seeing the highest death rates we have seen in the history of the business – not just at One America"**. Davidson said during an on-line news conference this week, "The data is consistent across every player in the business." Huge, huge numbers", **and it's not elderly dying but primarily working age people 18-64 who are the employees of companies that have group life insurance plans through One America.... the death rates are up 40% over what they were pre-pandemic."** Just to give you an idea of how bad that is, a three-sigma or a one -in-200-year catastrophe would be 10% increase over prepandemic" he said." **So, 40 % is just unheard of...** He continued, at the same time the company is seeing an uptick in disability claims, ... at first it

was short term disability claims and now the increase is in long-term disability claims “(203. Ibid, p.79)

### **18 U.S.C.§175**

(a) In General—Whoever knowingly develops, produces, stockpiles, transfers, acquires, retains, or possesses any biological agent, toxin, or delivery system for use as a weapon, or knowingly assists a foreign state or any organization to do so, or attempts, threatens, or conspires to do the same, shall be fined under this title or imprisoned for life or any term of years, or both. There is extraterritorial Federal jurisdiction over an offense under this section committed by or against a national of the United States.

(b) Additional Offense. —Whoever knowingly possesses any biological agent, toxin, or delivery system of a type or in a quantity that, under the circumstances, is not reasonably justified by a prophylactic, protective, bona fide research, or other peaceful purpose, shall be fined under this title, imprisoned not more than 10 years, or both. In this subsection, the terms "biological agent" and "toxin" do not encompass any biological agent or toxin that is in its naturally occurring environment, if the biological agent or toxin has not been cultivated, collected, or otherwise extracted from its natural source.

(c) Definition. —For purposes of this section, the term "for use as a weapon" includes the development, production, transfer, acquisition, retention, or possession of any biological agent, toxin, or delivery system for other than prophylactic, protective, bona fide research, or other peaceful purposes.

## **8. GENOCIDE: 18 U.S. CODE CHAPTER 50 A section 1091**

### **ANTHONY FAUCI BILL GATES AND THE ENTERPRISE VIOLATED THE LAWS AGAINST GENOCIDE, 18 U.S. CODE CHAPTER 50 A**

Genocide crimes are defined in 18 U.S. Code Chapter 50A. There are a total of three different statutes within Chapter 50, including a statute with definitions applicable throughout the chapter. The relevant federal laws related to genocide include:

**18 U.S. Code section 1091: Genocide:** Genocide is defined within 18 U.S. Code section 1091 to include killing members of a group; causing serious injury to members of a group; causing permanent impairment to members of a group; subjecting members of a group to conditions intended to be physically destructive; imposing measures to prevent births within the group; or transferring children by force from one group to another if that individual is motivated by the intent to destroy a national, ethnic, racial, or religious group. If death results because of the actions prohibited within 18 U.S. Code section 1091, a defendant can be sentenced to death or life imprisonment as well as a \$1 million fine. If no death results, the defendant can be sentenced to a maximum of 20 years imprisonment as well as a fine up to \$1 million. Inciting genocide can also result in up to five years of imprisonment and a fine up to \$1 million, and anyone who attempts or conspires to commit genocide will be punished in the same way as the person who commits the actual offense.

**18 U.S. Code section 1092: Exclusive remedies:** This statute makes clear that nothing found within 18 U.S. Code section 1091 precludes state or local laws, nor do any of the provisions of the federal statute create a substantive or procedural right enforceable by law by any party in any proceeding.

**18 U.S. Code section 1093: Definitions:** This statute defines specific terms that appear within Chapter 50A so it will be clear what the meanings of those words are and how they apply within the statute. For example, the term children is defined to include any individual who hasn't yet turned 18. The term ethnic group refers to any set of individuals whose identity is distinctive

because of common heritage or because of common cultural traditions. The term national group refers to a group of people whose identity is distinctive because of their national origin or nationality. The term racial group refers to a group of people who have a distinctive identity because of physical characteristics or because of biological descent. Finally, the term religious group refers to a group distinctive because it shares a common religious creed, doctrine, or set of beliefs or rituals. The term substantial part is also defined within 18 U.S. Code section 1093 to mean a big enough part of a group that the loss of that part of the group could cause destruction of the group as a viable entity within the nation that the group is part of..

## **9. Official Misconduct**

#### **Oregon Revised Statutes 162.415 Official misconduct in the first degree**

(1) A public servant commits the crime of official misconduct in the first degree if:

(a) With intent to obtain a benefit or to harm another:

(A) The public servant knowingly fails to perform a duty imposed upon the public servant by law or one clearly inherent in the nature of office; or

(B) The public servant knowingly performs an act constituting an unauthorized exercise in official duties; or

(b) The public servant, while acting as a supervisory employee, violates ORS 162.405 (Official misconduct in the second degree) and is aware of and consciously disregards the fact that the violation creates a risk of:

(A) Physical injury to a vulnerable person;

(B) The commission of a sex crime as defined in ORS 163A.005 (Definitions for ORS 163A.005 to 163A.235) against a vulnerable person; or

(C) The withholding from a vulnerable person of necessary and adequate food, physical care or medical attention.

(2) Official misconduct in the first degree is a Class A misdemeanor.

(3) As used in this section:

(a)“Supervisory employee” means a person having the authority, in the interest of an employer, to hire, transfer, suspend, lay off, recall, promote, discharge, assign, reward or discipline other employees.

(b)“Vulnerable person” has the meaning given that term in ORS 136.427 (Confessions). [1971 c.743 §215; 2017 c.519 §1]

#### **10. Corporate Misconduct: Oregon Revised Statutes 161.170 Criminal liability of corporations.**

##### **The CEOs OF PFIZER/BIOTECH, MODERNA, JOHNSON AND JOHNSON, ASTRA ZENECA AND THE ENTERPRISE KNOWINGLY AND WITH PURPOSE TO DEFRAUD USED THEIR RESPECTIVE CORPORATIONS FOR FURTHERANCE AND PROMOTION OF A CRIMINAL OBJECT.**

The corporations and their corporate officers involved in this great criminal deception have made billions of dollars for themselves and their stock holders. Their blood money plan implementation has taken the lives and welfare of millions of people. There needs to be an accounting of their actions, their profits, the injuries, deaths and financial losses their corporate criminal misconduct has caused.

#### **ORS 161.170 Criminal liability of corporations**

(1) A corporation is guilty of an offense if:

(a) The conduct constituting the offense is engaged in by an agent of the corporation while acting within the scope of employment and in behalf of the corporation and the offense is a misdemeanor or a violation, or the offense is one defined by a statute that clearly indicates a legislative intent to impose criminal liability on a corporation; or

(b)The conduct constituting the offense consists of an omission to discharge a specific duty of affirmative performance imposed on corporations by law; or

(c)The conduct constituting the offense is engaged in, authorized, solicited, requested, commanded or knowingly tolerated by the board of directors or by a high managerial agent acting within the scope of employment and in behalf of the corporation.

(2) As used in this section:

(a) “Agent” means any director, officer or employee of a corporation, or any other person who is authorized to act in behalf of the corporation.

(b) “High managerial agent” means an officer of a corporation who exercises authority with respect to the formulation of corporate policy or the supervision in a managerial capacity of subordinate employees, or any other agent in a position of comparable authority. [1971 c.743 §16]

## **11. ANTHONY FAUCI, BILL GATES AND THE ENTERPRISE COMMITTED NUMEROUS CRIMES OF CRIMINAL CONSPIRACY**

### **ORS 161.450 “Criminal conspiracy”**

(1) A person is guilty of criminal conspiracy if with the intent that conduct constituting a crime punishable as a felony or a Class A misdemeanor be performed, the person agrees with one or more persons to engage in or cause the performance of such conduct.

(2) Criminal conspiracy is a:

(a) Class A felony if an object of the conspiracy is commission of murder, treason or a Class A felony.

(b) Class B felony if an object of the conspiracy is commission of a Class B felony.

(c) Class C felony if an object of the conspiracy is commission of a Class C felony.

(d) Class A misdemeanor if an object of the conspiracy is commission of a Class A misdemeanor.  
[1971 c.743 §59]

On August 19, 1947, the judges of the American military tribunal, before rendering their verdict in the Doctors' Trial USA vs. Karl Brandt et al., presented ten basic principles for human experimentation 'in order to satisfy moral, ethical and legal concepts' under a section entitled Permissible Medical Experiments. They became known as the Nuremberg Code.

1. The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonable to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.
2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results will justify the performance of the experiment.
4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.
6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability, or death.

8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.

9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.

10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

This psychological operation involving bioweapons injected into people without informed consent is an experimental operation on many levels without informed consent or knowledge of the extent of the deception or harm which may include serious injury or death. All ten tenants of the Nurenberg Code have been violated by the Enterprise in using their counter measures.

#### **14. ANTHONY FAUCI, BILL GATES AND THE ENTERPRISE COMMITTED TREASON, VIOLATING 18 U.S. Code § 2381 and 2021 Oregon Revised Statutes Volume: 04 Section 166.005,Treason.**

The United States and its citizens have been under attack clandestinely for many years. The end game is the destruction of the Nation State and individual freedom through undermining the Constitution and the Bill of Rights. #### **Oregon Rev Stat § 166.005 (2021) Treason**

(2) No person shall be convicted of treason unless upon the testimony of two witnesses to the same overt act or upon confession in open court.

(3) A person convicted of treason shall be punished by imprisonment for life. [1971 c.743 §217]

### **15. 18 U.S. Code §2382. Misprision of Treason**

Whoever, owing allegiance to the United States and having knowledge of the commission of any treason against them, conceals and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States, or to the governor or to some judge or justice of a particular State, is guilty of misprision of treason and shall be fined under this title or imprisoned not more than seven years, or both.
