Dear Governor Murphy,

I am a New Jersey citizen, live in New Jersey and have children and grand-children who live in New Jersey. I am also a United States Army veteran, former New Jersey police officer and attorney, and President of the National American Renaissance Movement, a New Jersey non-profit corporation.

Included in this package being sent to you, your Attorney General and Commissioner of Health are 107 pages of Vaccine Adverse Events Reporting System (VAERS) case history synopsis dated from last year (1/27/23)

There are 25 pages reporting 205 deaths, 47 pages reporting 492 permanent disabilities and 36 pages reporting 372 life threatening events. Please review if you have not already.

Realizing, that according to the CDC and FDA that VAERS cases are underreported, the numbers cited above are only the tip of an iceberg representing only 1% to 10% of the actual events, the real figures are much larger.

The actual adverse events caused by the Covid-19 vaccination in New Jersey could be approximately **20,500 deaths, 49,200 permanent disabilities and 37,200 life threatening events** from the 1/27/23 VAERS reports.

The latest VAERS figures from New Jersey through May 31, 2024 are higher.

Died: **220**, up from 205 (1/27/23) which could convert to **22,000 deaths**.

Permanent Disability: **560**, up from 492 (1/27/23) which could convert to **56,000 permanent disabilities**.

Life threatening: 409, up from 372 (1/27/23) reported which could convert to **40,900 life threatening events**.

In 1976 the Swine Flu Vaccine was taken off the market because **25 people died**.

The National American Renaissance Movement considers two bio-weapons being involved with the Covid-19 crimes. Both of these professionals could be called upon for serious input if the State of New Jersey wants to reconsider their position on these Covid-19 vaccines based on new evidence. A serious crime has been perpetrated against New Jersey citizens.

To understand the nature of the criminal actions surrounding the Covid-19 it is helpful to have an understanding of the transhumanist agenda and who is supporting it and how it is being implemented.

The States of Texas and Kansas have civil actions against Pfizer for medical fraud. See **Exhibits 171 and 157** of Grand Jury Petition. The first two pages of the Kansas action is included herein.

The Florida Surgeon General Joseph Ladapo has stated that the Covid-19 vaccination should come off the market because they are very dangerous to human beings. **See Exhibits: 180, 181, and 182.**

A mandamus action filed pro se by Dr. Joseph Sansone in Florida demanding the Covid-19 vaccinations be removed from commerce by the Governor, is in the Florida Appellate Courts. **See Exhibits: 169 and 170**

Other states are organizing law suits presently.

The Grand Jury petition being submitted at this time is a request for action. It is comprehensive mentioning 15 crimes. However, the Fraud documented in this Grand Jury Petition is being addressed in part in both the States of Kansas and Texas and by Dr. Ladapo and Dr. Sansone in Florida. These civil actions should be seriously studied by the officials of New Jersey. You, the Governor, Attorney General and Commissioner of Health of New Jersey have been defrauded as well as the Citizens of New Jersey.

I sent to the Governor and Attorney General last summer an Executive Summary and request for a Grand Jury criminal investigation listing crimes associated with the Covid-19 vaccinations, presenting an 83 -page document. I had never heard back. I am resubmitting an amended Grand Jury Petition of 90- pages requesting that the documents submitted herein, the Executive Summary and Grand Jury Petition including this letter of request listing Exhibits be given to the Grand Jury for review.

The National American Renaissance Movement is willing to volunteer to assist law enforcement in an investigation of Covid-19 and the vaccinations deployed. If I or my colleagues at the National ARM can help your office, please advise.

The National American Renaissance Movement is requesting that your office order:

1. An in depth and comprehensive forensic science investigation into the content of the Covid-19 vaccinations by the State of New Jersey. Are they safe and effective? This should be answered by professionals with no bias.
2. The submission of the Grand Jury Petition and Executive Summary to the Grand Jury for review.
3. The consideration by the State of New Jersey of filing similar civil actions as has been commenced by the States of Texas and Kansas for Consumer Fraud as the vaccines were neither safe nor effective in preventing infection or transmission. (New Jersey has almost four times the number of total VAERS reports as Kansas.) Pfizer is said to have profited over 100 billion dollars from the distribution of these dreadful vaccinations which neither stopped infection nor transmission, shut the State down, and which subjected everyone to major inconveniences and possible serious health risks.
4. The Commencement of a Grand Jury criminal investigation concerning numerous crimes associated with the Covid-19 pandemic, documented in the Grand Jury Petition and Executive Summary. The crime of Fraud would be a good place to start. See Grand Jury Petition **pages 13-45**.
